# Message from the President



Antimicrobial Resistance (AMR) has caused a media storm over the past two months with a lot of discussions amongst primary care doctors. Being the Chairman of the Advisory Group for Antibiotic Stewardship Programme (ASP) in Primary Care under the umbrella of Centre for Health Protection (CHP), I might be the best person to explain the ins and outs.

The burden of AMR in United States alone (2013) caused more than 23000 deaths, 2 million infections,

direct healthcare costs in excess of US\$20 billion and loss of productivity at US\$35 billion. AMR does not respect country border, and is an international threat. It has been estimated that if no effective measures are implemented by 2050, 10 million annual deaths or one death in every three seconds and loss of 2-3% global GDP accounting to US\$ 100 trillion could be incurred. This is the dire number one heath issue we are all facing at the moment.

The first world Antibiotic Awareness Week (AAW) was initiated by the World Health Organization (WHO) started in 2015. It aims to increase awareness of global AMR and to encourage best practices among the general public, healthcare workers and policy makers to avoid the further emergence and spread of AMR. 13 to 19 November 2017 was the AAW, themed as "Seek advice from a qualified healthcare professional before taking antibiotics". Appropriate use of antimicrobial agents is one of the essential factors in controlling the emergence of antimicrobial resistance (AMR). To echo the health promotion activities during AAW, the Centre for Health Protection announced the launch of Antibiotic Stewardship Programme (ASP) in Primary Care.

Antibiotic Stewardship is defined as coordinated interventions designed to improve and measure the appropriate use of antibiotics by promoting the selection of the optimal antibiotic regimen including dosage, duration of therapy and route of administration. ASP in Primary Care in UK, US and France results in significant reduction of antibiotic use with no significant change in admissions to hospital, reconsultations or costs.

ASP has been identified as a key measure for reducing unnecessary prescriptions, suppressing AMR emergence, and at the same time controlling medical expenses. The development and implementation of ASP is relatively mature in local hospital settings. However, the support for and promotion of proper use of antimicrobials can be enhanced in the primary health care setting. The Advisory Group is chaired by me and composed of key stakeholders from local experts and academia in the fields of family medicine, microbiology, public health, pharmacology and professional bodies such as the Hong Kong Medical Association, the Hong Kong Doctors Union and healthcare maintenance organizations from the community. We started working in March 2017 for developing a series of evidence-based guidance notes for common infections in primary care. Currently, three guidance notes on acute pharyngitis, acute uncomplicated cystitis in women, and simple (uncomplicated) skin and soft tissue infections have been published and the development of other guidance notes for common infections will continue. In addition, education materials for patients such disease information sheets, posters and pamphlets are also produced to facilitate doctors in explaining the nature of infectious diseases, importance of compliance with doctors' instructions and advising the public not to use antibiotics indiscriminately.

So how serious is AMR in Hong Kong? According to DH statistics, the number of community-associated methicillin-resistant Staphylococcus aureus (MRSA) cases notified to the CHP has increased five-fold in the past nine years with approximately 1,000 reports annually in the recent three years. Hospital Authority Superbug Report 2011-2016 showed the

percentage of isolates cultured to have multi-drug resistant organism: MRSA about 45% and ESBL producing E coli about 35%. What it means is we are near the top of the global AMR league!

So who should take the blame? Certainly not the primary care doctors! The antibiotic prescribing rate for URTI (2014) in Hong Kong was 5-6% (decreased from 8% in 2005; and when compared with 50% in Australia and 80% in China which was one of the lowest in the Asia Pacific region. The liberal use of antibiotic in poultry and cattle imported to Hong Kong has not gone unnoticed. Antibiotics like Cephalosporin which have a shorter half-life are commonly used in cattle farming and untraceable by the time the cattle was sold. However, a local study by the Chinese University of Hong Kong in 2016 on cough showed the antibiotic prescribing pattern: 17.4% in private versus 1.6% in public consultation. The clinicians' perception of benefit from antibiotic, patients' request and their expectation, as well as the severity of symptoms are the reasons for antibiotic use. Diagnostic uncertainty is the most common reason for local doctors to prescribe antibiotics to patients with URTI.

The challenges we are facing: Firstly, use of diagnostic tests are not common as cost of laboratory testing and the report timing of specimen culture which will take 3 days make doctors rely heavily on their clinical judgement. Decision to prescribe antibiotics is rarely based on definitive diagnosis. Evidence-based prescribing and dispensing should be the standard of care.

Secondly, the lack of local epidemiology data on resistance pattern of common pathogens especially in private primary care is another hot issue. The establishment of our advisory group is not for compulsory surveillance of antibiotic use in private sector though we will try to work out possible ways to understand the private practice in antibiotic use and to evaluate the effectiveness of programme. We are going to conduct a survey by obtaining feedback from primary care doctors through questionnaires during training sessions. Their views on awareness, usefulness of ASP materials and their frequency of antibiotic prescription for the three diseases in the quidelines will be collected. We have approached HMOs for feasibility to get their data for analysis. Though they have reservation to provide data due to privacy issue, they start to move forward by looking into the antibiotic use in their organisations. The use of electronic channel like eHRSS is not well adopted by primary care doctors for record sharing though this method will progress down the years and should be encouraged. I have heard a microbiologist who recommended taking photos of medication bags and submitting to Department of Health for data collection. This is impractical and can be misleading. The bag is dumb about the clinical presentations, working diagnosis and background situations.

Thirdly, public and patients' support for reduction of unnecessary antibiotic prescription is essential. The survey by CHP indicates 97% of Hong Kong people agree to non-prescription of antibiotic if doctor explains clearly. Another survey shows a staggering 54% of people misunderstand antibiotic can cure URTI. That is why patient education is of prime importance.

I can summarize the following keys points: 1. Optimisation of antimicrobial use is one of the keys to combat AMR. 2. Enhance surveillance on antimicrobial resistance and antimicrobial use in primary care is an important initiative. 3. Doctors should prescribe antibiotics when indicated and with reference to the latest local prevalence and susceptibility profiles. 4. Development of guidelines to provide doctors with the knowledge and confidence of appropriate standard of antibiotic prescription should be a future direction. 5. Good doctor-patient relationship enhances judicious use of antibiotics by patients through education. 6. Antibiotics are our precious resources and everybody has the responsibility to treasure and prevent its misuse.

# THIRTY-SECOND CONJOINT HKCFP/RACGP FELLOWSHIP EXAMINATION FIRST Announcement

The Board of Conjoint Examination is pleased to announce the following information on the Thirty-second Conjoint Fellowship Examination with the Royal Australian College of General Practitioners to be held in 2018.

#### (1) REQUIREMENTS AND ELIGIBILITY

All candidates **MUST** be at the time of application for the Examination and at the time of the Conjoint Examination:

- 1. FULL OR ASSOCIATE members of BOTH HKCFP AND RACGP\*
- 2. FULLY REGISTERED with the Hong Kong Medical Council\*

(\*Documentary evidence is required with the application – including a valid RACGP number.)

(**Note**: All candidates are required to renew their RACGP membership for the year 2018/2019 before 31 July 2018. Failure to comply with the rule may result in denial of admission to the Exam.)

In addition, they must be EITHER CATEGORY I OR CATEGORY II CANDIDATES: -

(a) **CATEGORY I CANDIDATES** are graduate doctors who are undergoing or have completed a fully approved vocational training programme as outlined in the College's Handbook for Vocational Training in Family Medicine.

After satisfactory completion of two years of approved training, Category I candidates or trainees may apply to sit the Written Examination, both the two segments of which must be taken at the same attempt. After satisfactory completion of four years of supervised training, Category I candidates may apply to sit the Clinical Examination.

[Note: All Category I candidates who are current vocational trainees and apply to sit the Written Examination MUST submit evidence of completion of at least 15 months of approved training by 31 March 2018, together with the application. Those current vocational trainees who apply for the Clinical Examination MUST submit evidence of completion of at least 39 months of approved training by 31 March 2018, together with the application. Candidates who have already completed vocational training MUST submit evidence of completion of vocational training, together with the application.

Part-time trainees must submit evidence of completion of their vocational training by the time of the Written Examination before they can apply to sit the examination.)

(b) **CATEGORY II CANDIDATES** are doctors who have been predominantly in general practice for not less than **five** years by 30 June 2018.

Category II candidates may opt to only sit for the Written Examination at the first and subsequent application. Enquiries about eligibility to sit the examination should be directed to the Chairman of the Board of Conjoint Examination.

The eligibility of candidates of both categories is subject to the final approval of the Board of Conjoint Examination, HKCFP.

Application will not be processed unless all the documents are submitted with the application form.

#### (2) FORMAT AND CONTENTS

A. Written Examination

Applied Knowledge Test (AKT)\*, and

Key Feature Problems (KFP)

- \*Note: Applied Knowledge Multiple Choice Questions (MCQ) has been renamed as Applied Knowledge Test (AKT), with no change on the exam format.
- B. Clinical Examination
  Objective Structured Clinical Examination (OSCE)

#### (3) PRE-REQUISITE FOR CLINICAL SEGMENTS

All candidates applying to sit for the Clinical Examination of the Conjoint Fellowship Examination MUST possess a APCLS (Advanced Primary Care Life Support) certificate issued by the HKCFP\*. This validity of this certificate must span the time at which the application for the Examination is made AND the time of the Clinical Examination.

#### Application will not be processed unless the pre-requisite is fulfilled.

\*Note: Regarding the APCLS certificate as issued by the HKCFP, the APCLS workshops & examinations for 2018 will be held on **24 - 25 February 2018** and **24 - 25 March 2018** respectively. Details regarding the workshop / examination can be referred to the News of the Board of Education (on pg. 25). Please register with our College secretariat at 2871 8899 IMMEDIATELY if you do not hold a valid APCLS certificate issued by HKCFP and intend to sit for the Conjoint Examination 2018.



#### (4) CRITERIA FOR A PASS IN THE EXAMINATION

A candidate will be required to pass the entire Written Examination in one sitting. That is, if one fails the Written Examination, both the AKT and KFP segments have to be re-taken. Successful Written Examination result can be retained for three years (until the Clinical Examination of 2021).

The Clinical Examination can only be taken after successful attempt of the Written Examination. If one fails the Clinical Examination, all the OSCE stations have to be re-taken.

A candidate has to pass both the Written and the Clinical Examinations in order to pass the Conjoint HKCFP/RACGP Fellowship Examination.

#### (5) APPLICATION AND EXAMINATION FEES

Application forms are available from the College Secretariat at Room 803-4, HKAM Jockey Club Building, 99 Wong Chuk Hang Road, Aberdeen, Hong Kong. [\*Note: For candidates who are first sitting for the OSCE exam and have passed the Written Examination in 2015-2016, provided that the administration fee for the whole Conjoint Examination had been previously settled, only the Clinical Examination fee of \$14,500 would apply, that is, the application fee of \$3,000 would NOT apply.]

If a candidate wishes to withdraw from the examination, and written notice of withdrawal is received by the College 60 days or more prior to the date of the examination, he will receive a refund of \$29,000 (for the whole examination), \$14,500 (for the written examination) or \$14,500 (for the clinical examination). The application fee of \$3,000 will not be refunded.

No refund will be given if the written notice of withdrawal is received by the College within 60 days of the date of the examination.

All fees paid are not transferable to subsequent examinations.

# 130/80mmHg Instead of 140/90mmHg... What Would Be the Possible Impact for Management of Hypertensive Patients in Our Locality?

The 2017 American College of Cardiology/American Heart Association (ACC/AHA) Guideline for the Prevention, Detection, Evaluation and Management of High Blood Pressure in Adults had recently updated recommendations for 1. the definition of hypertension, 2. systolic and diastolic blood pressure thresholds for initiation of antihypertensive medication and 3. BP target goals, with the emphasis on monitoring blood pressure at home.

# Brief comparison on JNC 7 and the new 2017 ACC/ AHA guidelines

 Comparison in JNC7 and 2017 ACC/AHA Hypertension Guidelines in BP definition

SBP, DBP (mm Hg)	JNC7	2017 ACC/AHA
<120 and <80	Normal BP	Normal BP
120–129 and <80	Prehypertension	Elevated BP
130–139 or 80–89	Prehypertension	Stage 1 hypertension
140-159 or 90-99	Stage 1 hypertension	Stage 2 hypertension
≥ 160 or ≥ 100	Stage 2 hypertension	Stage 2 hypertension

2. Comparison of thresholds for initiation of antihypertensive medication

#### JNC7

Initiation of antihypertensive medication from all Stage I hypertension

#### 2017 ACC/AHA

The use of antihypertensive drugs is to be guided by blood pressure as well as the presence of cardiovascular disease (CVD), diabetes, or a 10 year risk of developing CVD of more than 10%. Only prescribing medication for Stage I hypertension if a patient has already had a cardiovascular event such as a heart attack or stroke, or is at high risk of heart attack or stroke based on age, the presence of diabetes mellitus, chronic kidney disease or calculation of atherosclerotic risk (using the same risk calculator used in evaluating high cholesterol).

3. Blood pressure goals for patients with hypertension INC 7

goals of antihypertensive therapy were to achieve a BP of:

- <140 / <90 mm Hg for patients with uncomplicated hypertension
- <130 / <80 mm Hg for patients with diabetes or chronic renal failure

#### 2017 ACC/ AHA

For adults with confirmed hypertension and known diabetes, chronic renal disease, CVD, or a 10-year ASCVD risk of 10% or more, a BP target of less than 130/80 mmHg is recommended.

For adults with confirmed hypertension without additional markers of increased CVD risk, a BP target of less than 130/80 mmHg may be reasonable.

#### Potential impact on our management

- With this guideline, more pre-hypertension will be classified as having hypertension.
- More patients will be started with antihypertensive by the new definition, but with smaller increase in proportion compared with patients classified as hypertensive.
- The new guideline stresses on the importance of using proper technique to measure blood pressure. Blood pressure levels should be based on an average of two to three readings on at least two different occasions.
- The guideline also stresses on the importance of home blood pressure monitoring using validated devices and appropriate training of healthcare providers to reveal "white-coat hypertension" and "masked hypertension".
- The guideline also promotes team-based system approaches for better diagnosis and management of hypertension.
- Public awareness will be raised on the issue of hypertension. We should take this opportunity to have more public education on CVD prevention, especially healthy lifestyle interventions, such as healthy diet, physical exercise, weight loss, and reduced sodium intake.

# Initial response from local health authorities in Hong Kong

- the current guideline of 140/90mmHg would be reviewed and at the mean time the current guideline will be maintained, with close monitoring of the latest development of scientific evidences and practices of other areas on hypertension management.
- The population of hypertensive patients in our locality was estimated as 860,000, which is around 12.6% of the general population. The prevalence of hypertension in our locality will also be reviewed.



# **GP17 RACGP Conference, Sydney, Australia**

"General practice: The foundation of patientcentred care" is the theme of this year's annual conference of the Royal Australian College of General Practitioners (RACGP) held in Sydney on 26-28 October 2017.

GP17 was preluded by a day of Active Learning Modules (ALMs) designed for practising GPs to refresh their clinical skills and to learn hands-on in a variety of workshops. These ranged from Dermatology for GPs, emotional health of children, back pain assessment and management skills, to point of care ultrasound for rural GPs, just to name a few.


Apart from keynote lectures, GP17 was structured under five main streams, namely 1. Better systems and data, 2. Education and research, 3. Health equity, 4. Quality care, and 5. Sustainability and financial modelling. Presentations included lectures, sharing from patients, small group discussions, interactive quiz-based seminars, etc. All these worked as gathering points for Australian GPs to learn, to refresh and to supplement their clinical and business skills. It is rightfully said that the RACGP annual conference discusses the issues relevant to GPs.

Our GP17 journey started right after we landed at the Sydney International Airport at 08:10. We rushed off to the venue. International Conference Centre (ICC) Sydney in Darling Harbour, after we briefly settled at our hotel. We battled through the day of conference and the hypersomnolence after a 9-hour


overnight flight with coffee and tea. We were excited to see how RACGP organised their annual conference. The scale and details were remarkable - they had a team of helpers to guide participants to navigate the spacious conference venue, and their tea break area was situated in a hall where sponsors showcased their products and services in various booths. What products could we see there? Dermoscopes, health products, and even a mini car show!

The topics covered in GP17 were well suited to different GPs. While some topics were less relevant to family doctors from Hong Kong, we were most impressed by two presentations. In one lecture, the speaker presented his evidence-based review of the benefits and myths of statins in lowering cardiovascular risks. The majority of the medical profession might take it for granted for quite some time that statins reduce cardiovascular risks. But the speaker delivered an unbiased review of the literature on the relation between statins, LDL levels and actual cardiovascular outcome rates. The conclusion was that it is not beyond doubts that statins always improve cardiovascular outcomes! In another lecture, a patient suffering

from narcotic dependence because of her multiple postoperative pains shared on stage her long journey in seeking treatment and living with her narcotic

analgesics. Her speech was touching and reflected perhaps a small group of Australian patients' sufferings from this difficult problem. From this lecture, we heard the patient's voice, as well as the questions and criticisms from the floor regarding the long waiting lists at specialist narcotic dependence treatment centres. These two lectures sharpened our mind and reminded us of the health systems in our locality.

During tea and lunch breaks, delegates could also view the poster presentations located in the same hall. We were glad to see a few posters from the public and academic sectors of Hong Kong. And we were even happier to bump into other delegates from Hong Kong. After a tiring and packed schedule in day one, a big group of us gathered for a nice dinner with beef and seafood. When night fell, we strolled along the Darling Harbour and retired to our hotel.

GP17 conference also enlightened us in a couple of aspects regarding their planning and arrangement. Foremost is the conference's family-friendliness. There was a nursery area for young children saving conference participants' hassle in child-care. GP17 also launched a dedicated smart phone App with programme time table, programme abstracts, and alert alarms built-in. Comprehensive WiFi coverage across the venue facilitated instant access to programme information and functioning of the smart phone App. The good WiFi support also enabled realtime clinical guiz and web-based interactions between speakers and the floor. Modern wireless technologies allowed for a near paperless conference environment and could be considered by our local Primary Care Conference.

GP17 also boosted a high proportion of abstract sharing sessions with oral presentations. The number of poster presentations were relatively low compared to our local conferences. This could be a deliberate effort of GP17 to encourage oral presentations and speaker-audience

interaction. We could also see that a good proportion of poster presentations were submitted by overseas institutions, which reflected the popularity and fame of the RACGP conference. Another important observation was that GP17 ran a high number of parallel sessions to allow for diversified topics available to the participants. This was particularly important for a conference in family medicine / general practice as the specialty covers a wide scope of clinical and management skill sets.

香港家庭醫學學院於1977年建立,是香港醫 學專科學院十五間創院學院之一,今年剛好40 週年。我們學院在這40年中形成了一套規範化 的家庭醫生在職培訓,不斷完善,每年舉行一 次和澳洲皇家全科醫學學院(RACGP)聯合的 院士考核,通過者可以擁有香港家庭醫學學院 和澳洲皇家全科醫學學院的院士資格。

這次會議,陳智偉醫生跟大家分享了在香港家 庭醫生的成長過程。不同於剛剛起步的大陸醫 療系統,香港家庭醫學已經是一個很成熟的專 業。近年畢業的醫學生基本都能按自己的喜好 選擇專業,家庭醫學的受歡迎程度也是靠前 的。這和在大陸並不一樣。

因為會議時間比較寬裕,陳醫生介紹完之後, 大會增加了現場問答問題時間。在場的青年醫 牛都好像比較羞澀,最後主持人華西醫院李雙 慶主任幫這些青年醫生提了兩個很接地氣的問 題。一個是"香港家庭醫生的收入和其他專科 差別大嗎?"另一個是"病人所用藥物如何收 費?"中國大陸現在面對的情況就是好的醫學 生大多數不願意選擇全科醫生,收入不公應該 是其中一個很大的有待解決的問題。在市場經 濟之後大陸醫療系統"以藥養醫"的情況屢禁 不止,現在好像硬性提高檢查的收費比例,但 並沒有從根本上解決問題。

兩地家庭醫學的起點相差甚遠,兩個醫療體系 也大相徑庭,求同存異再互相了解學習,在將 來期待會有更多的交流。

# **HKCFP Best Research Award 2016 and HKCFP Research Fellowship 2017**

The Research Committee is delighted to announce that the study on "How do primary care doctors diagnose depression? A decision tree analysis of the pathways leading to the diagnosis of depression" has been awarded the HKCFP Best Research Award 2016. The Committee would like to congratulate the principal researcher Dr. Chin Weng Yee for her work.

It is also our pleasure to announce that the winner of the **HKCFP Research Fellowship 2017** is Dr. Wong Sze Kei. The research topic is 'Effect of de-prescription on the functional capacity of elderly patients with polypharmacy: a cohort study from the primary care setting'.

Dr. Wong Sze Kei graduated from University of Hong Kong. She has been working in general out-patient clinic since graduated from medical school. She obtained the HKCFP/RACGP Conjoint Examination Fellowship in 2016. She is currently having the first year of higher training in Family Medicine.

Deprescribing is the process of trial withdrawal of inappropriate medications, with the goal of managing polypharmacy and improving the clinical outcomes. Deprescribing has the potential to greatly improve health outcomes through stopping or reducing the dose of inappropriate medications; but, currently, concrete evidence regarding its effect is equivocal. Locally, significant proportions of elderly patient with polypharmacy are managed in the primary care and followed up at government General Out-patient Clinics (GOPCs) of the Hospital Authority. Given the risks of polypharmacy and inappropriate medication use in older persons, Deprescription Clinic (DPC) was set up at Yau Ma Tei GOPC since August, 2016 adopting a sensible approach to address this issue. This study tries to explore the clinical effectiveness of DPC and to evaluate

its impact on the functional assessment among the elderly patients. Through a team approach with prudent deprescription, it is expected that the quality of life and functional capacity of the elderly with polypharmacy could be improved whereas their chronic disease control will not be compromised.

Methods: Study design and setting: a prospective study to be conducted in a primary care clinic in the Hospital Authority (HA) of Hong Kong.

Subjects: Inclusion criteria are patients who are aged 65 or above, have been on more than 10 medications in total among which at least 5 are chronic medications and have been regularly followed up at DPC of Yau Ma Tei Jockey Club GOPC (YMTJC) of Kowloon Central Cluster from 1 Jan, 2017 to 30 June, 2018. Primary outcome will be the median number of regular medications taken by participants (number of drug items, number of total pills and number of frequency before and after intervention). The secondary outcomes include control status of chronic diseases (Blood pressure among HT patients and glycaemia control among DM patients); cognitive function (by abbreviated mental test); Independence in activities of daily living (ADLs, by Modified Barthel Index), Risk of falls, Quality of life (by questionnaire SF-36), AED/ hospital attendance and survival/mortality. These data at baseline level and one year after follow-up at DPC will be collected. The patients' age, gender, smoking status, latest blood pressure level will be retrieved from the Clinical Management System (CMS).

Likely outcomes and benefits: DPC is effective in reducing the number of inappropriate medication use among elderly patients with polypharmacy. Meanwhile, their chronic disease control is not compromised. Some functional assessment parameters such as fall risk or quality of life will also be significantly improved.



#### Advanced Primary Care Life Support (APCLS) Training and Examination Workshop 2018

As required by the Royal Australian College of General Practitioners (RACGP), CPR training course needs to have advance component on airway management, neck support and automated external defibrillation (AED) on top of basic life support. In order to align with our Sister College (RACGP) and in achievement of reciprocal recognition in Conjoint Fellowship Examination and Quality Assurance Certificate, the CPR Subcommittee of the Board of Education is pleased to announce that an enhanced CPR course, the Advanced Primary Care Life Support (APCLS) has been launched in 2017.

APCLS course materials have been endorsed by HKCFP Council in 2015 and the Resuscitation Council of Hong Kong (RCHK) in 2016. The course aims to widen the scope of our existing CPR training course by adding several important elements: use of automated external defibrillator (AED), use of airways adjuncts and dealing with initial trauma care through use of neck support.

TWO APCLS Training and Examination Workshops will be held in 2018 (24-25 February 2018, 24-25 March 2018).

As no one is guaranteed to pass in the first attempt, members who plan to sit for the 2018 Conjoint Examination are strongly advised to register in our APCLS session. Members are reminded that a valid HKCFP CPR Certificate is a pre-requisite for enrolment of the Conjoint Examination. Members who plan to sit for the 2018 Conjoint Examination are also reminded to check the validity of their HKCFP CPR Certificate to make sure that it is valid at the time of application and also at the time Clinical Examination.
