Message from the President



Here comes the Medical Registration (Amendment) Bill 2017 or Bill 2016 Mark II again on the Medical Council reform. The Bill returns with two main changes. Firstly, Medical Council (MCHK) members will increase from the current 28 to 32 with four additional lay members, the latter will not be appointed by the Chief Executive of Hong Kong SAR. Three of the lay members will be elected from recognized patients' groups

and the fourth will be nominated by the Consumer Council. Secondly, the two appointed seats now held by Hong Kong Academy of Medicine will also be elected by the Academy. The latest Bill also proposes more than one Preliminary Investigation Committee and the number of assessors will increase from 28 to 140 in order to clear the backlog of medical complaints.

Bill 2016 had caused a storm in our medical field and was stalled and filibustering staged by the medical-sector lawmaker. Last year the President of Hong Kong Medical Association (HKMA), Dr. Louis Shih resigned due to the lack of support to call for referendum to release the 7 seats occupied by HKMA for open election by all its members. The result was no winner and the reputation of doctors was severely damaged! I consider inadequate government consultation as the main cause of failure.

This time the government had set up a Tripartite Platform to collect viewpoints from different stakeholders but when the proposed amendment was announced in May 2017, I was really disappointed! I have always argued for the betterment of the Medical Council and all the doctors, and the uniqueness of HKAM in postgraduate training and examination, it should have more representation within the MCHK rather than the mere two. Redistribution of the current allocation of representation from various medical bodies in MCHK is desirable. In fact the Academy had requested an extra three seats. Our College is one of the 15 constituent Colleges which are equally represented at the HKAM Council. The Academy and her Colleges can certainly influence the training curriculum, enhance the education of doctors and through continuing medical education improve risk management and alter undesirable behaviour. Again, the government doesn't listen and the increase in representation is not even mentioned.

Hong Kong doctors still command a high degree of respect from the public. Doctors to laypersons ratio in the Medical Councils in Canada, Australia and New Zealand are 2:1. In United Kingdom, the ratio is 1:1 and all its members are appointed following an independent appointment process. With the lastest Bill 2017, half of the MCHK will be elected while the share of appointed seats will go down from half to one third. However, with the incumbent Chief Executive leaving his post and lawmakers from both pro government and pan democratic groups gather under the flags of

transparency, accountability and credibility, I can only see the Bill going through the Legco without much resistance.

I had explained through FP Links that election of representatives via the HKAM Council demonstrates fairness to all Colleges irrespective of their sizes, which vary significantly from under 200 to over 1,600 Fellows. A general polling is fair to individual Fellows but may sacrifice the rights of Colleges with a smaller number of Fellows. Weighing the two, the rights of Colleges are more important than individual, as each specialty College makes an equal contribution to the public. The sad reality is our College ranked sixth in size within the Academy. A general election from all AM fellows is unfair to those Colleges with fewer fellows, as the two biggest Colleges namely the Physicians and the Surgeons will always be represented at MCHK. If the seats of HKAM are opened for nomination or election, I will actively campaign for fairness and participation of our AM fellows. Those elected by the HKAM Council to sit in MCHK needed to have the necessary experience, qualification, reputation and respect of the medical profession. Under the current system, we had two top guns, namely Prof Donald Li and Prof Cindy Lam served for MCHK from 2009 to 2012. With the volume of complaints regarding primary care doctors at the MCHK, it is simple logic that our College has representation at MCHK.

Dr. Harold Shipman, a GP in England, was convicted in 2000 of the murder of fifteen of his patients and sentenced to life imprisonment. After his trial, a full inquiry into all deaths certified by Shipman concluded that he was probably responsible for about 250 deaths. Some of us may think Shipman's case as impetus for the change and addition of lay members to General Medical Council UK (GMC) and MCHK is the copycat. In fact the reform of GMC was long overdue and the major change was to speed up the introduction of revalidation. Revalidation was not drawn up in response to the Shipman inquiry, but proposed by the GMC even before Shipman was arrested. Its rationale was not to uncover criminality, was never intended to catch another Shipman, but to fill a gap in the regulatory framework whereby, barring serious concerns being raised, doctors could practise from registration to retirement without any check on their performance or competency. Revalidation is to encourage increasing quality in healthcare for patients through self-assessment, appraisal, continuing medical education and reflective practice. Hong Kong loves to compare with Singapore. Looking at the Singapore Medical Council home page, the first message highlights on the top: "the

Council has implemented compulsory CME with effect from 1 January 2003". Singapore is way ahead of us by 14 years!





一對早已拍着拖來看醫生的戀人,同來做婚前檢查,婚後太太過來驗孕,我們一同分享迎接新家庭成員的喜悦;女兒出生後到診所打預防針,作為家庭醫生看著襁褓中的嬰孩日漸成長變成婷婷玉立的少女,醫患關係早已超越成家庭成員。但作為家庭成員之一,我們同時也得面對疾病與死亡:為病人公佈患上惡疾的壞消息,與病者家人同為失去至親而傷痛。或許就是這種人與人之間的聯繫,才是我最希望成為家庭醫生的原因。

我的家庭醫生之路才剛起步,由衷感謝路上遇上的各位老師,還有當年那位「問長問短」的 林永和醫生及「關顧病人」的何敬業醫生。





What's your "WONCA"?

WONCA is an acronym comprising the first five initials of the World Organization of National Colleges, Academics and

Academic Associations of General Practitioners/ Family Physicians. WONCA 's short name is World Organization of Family Doctors.

What is WONCA 's mission?

The mission of WONCA is to improve the quality of life of the people of the world through defining and promoting its values, including respect for universal human rights and including gender equity, and by fostering high standards of care in general practice/ family medicine by:

- Promoting personal, comprehensive and continuing care for the individual and the family in the context of the community and society;
- Promoting equity through the equitable treatment, inclusion and meaningful advancement of all groups of people, particularly women and girls, in the context of all health care and other societal initiatives:
- Encouraging and supporting the development of academic organizations of general practitioners/ family physicians:
- Providing a forum for exchange of knowledge and information between Member organizations and between general practitioners/family physicians;
- Representing the policies and the educational, research and service provision activities of general practitioners/family physicians to other world organizations and forums concerned with health and medical care.

Who is WONCA?

The World Organisation of Family Doctors (WONCA) is a not-for-profit organization and was founded in 1972 by member organizations in 18 countries. Currently, WONCA has 118 Member Organizations in 131 countries and territories with membership of about 500,000 family doctors and more than 90 percent of the world's population. This includes eight organizations in collaborative relations with WONCA. There are some 21 members in the Academic membership category, which consists of Academic and Departments of Family Medicine. Over 800 individual general practitioners and family physicians have chosen to join WONCA in their own right Membership of WONCA.

WONCA represents and acts as an advocate for its constituent members at an international level where it interacts with world bodies such as the World Health Organization, with whom it has official relations as a non-governmental organization and is engaged in a number of collaborative projects.

WONCA Structure

WONCA is governed by a World Council. The Council comprises the representatives of member organizations and the officers of WONCA. The Council elects an Executive Committee that consists of the President, President-Elect, three Members-at-Large, and a Regional President from each of the seven regions.

Dr. Donald KT Li (MBBS FHKCFP) FRACGP FHKAM(Fam Med) FFPH SBS O St J JP) was elected as President Elect of WONCA in November 2016 and will take office as President in November 2018. (Dr. Li is the Immediate



Past President of the Academy of Medicine of Hong Kong). And Dr. Li is a Past President and currently Censor of our College.

WONCA has seven regions, each of which has their own regional Council and run their own regional activities including conferences. The seven regions are Africa, Asia Pacific, East Mediterranean, Europe,



Iberoamericana, North America, and South Asia. WONCA Asia Pacific are one of the largest regions of WONCA. Our College is one of the Hong Kong member organizations under WONCA Asia Pacific. Dr. Gene Tsoi, one of our College Past Presidents, is the Vice President of WONCA Asia Pacific.



The upcoming WONCA Asia Pacific Region Conference would be held in Pattaya City, Thailand from the 1st to 4th of November 2017. The theme of the conference is ' Family Medicine Innovation: Challenges Facing Family Physicians in the 21st Century'. The conference will cover most of the family medicine topics from state of the art to advances of technologies and future medical trends. Communities' issues will also be shared and discussed, such as elderly and palliative care and environmental issues. And it would be an opportunity





for family doctors to gather and share research and practice experiences. The HKCFP Council would grant sponsorship to members to show the support of such a good occasion to foster ties between family practice organizations as well as individual doctors. Interested family medicine colleagues should not miss this precious chance to meet our professional colleagues over the world.

Local Health Apps for the General Public

Since my last introduction of mobile health-related apps 2 years ago (Feature Sections of the FP Links, Issues July, September and October 2015), a range of new health-related apps had been launched locally for use of the general public. I would like to run a brief introduction to some of these apps in this issue, so you can familiarise with them and opportunistically introduce to your patients in need during our daily consultations.

Section A : Apps for Diet

Different from the diet apps that were previously introduced, these apps were launched by the Department of Health (DH) and are aimed to serve as platforms to provide locals more tailored information towards healthy eating.

When cooking idea runs out, the "CookSmart: EatSmart Recipes"(營廚雜誌:有營食譜) app may help by providing a vast range of healthy recipes that were designed by various dietitians. Another related app is the "EatSmart Restaurant" (有營食 肆) app that can help us choose restaurants that offer healthier dishes when dining out. Whereas the "Snack Nutritional Classification Wizard"(小食營養分類精 靈) app is a database that helps us learn more about common food labels and be more vigilant against unhealthy snacks by an easily understandable "traffic light" system (e.g. "red light" items are unhealthy food choices that are too high in either sodium, fat or sugar contents; whilst "green light" items are wiser choices). I think these diet apps are useful tools that can help us offer more concrete and practical eating advices for our puzzled patients.

Regulations on Assisted Reproductive Technology in Hong Kong

As in other developed Asian economies such as Japan and Singapore, the low fertility rate in Hong Kong is marked by decreasing marriage rates and a tendency to postpone marriage and childbearing. The crude birth rate in Hong Kong has dropped significantly from 35.0 per 1,000 population in 1961 to 7.0 per 1,000 population in 2003, then raised to 13.5 per 1,000 population in 2011, and dropped to 8.2 per 1,000 population in 2015. ¹

The drop in birth rates is due to multiple factors including decreased marital rates, postponed marriage and thus postponed child bearing plans, concerns about the social and financial burden of raising children in an increasingly competitive society. The proportion of never married women aged 40-44 was 17% in 2011, up from 3% in 1981. Our median age at first marriage for women was 28.9 in 2011, compared with 23.9 three decades ago. ² The Family Planning Knowledge, Attitude and Practice in Hong Kong Survey 2012 commissioned by the Hong Kong Family Planning Association showed that "too much responsibility" and "heavy financial burden" are the two main concerns cited by those who did not want to have children, or more than one child. The Survey also showed that on the other hand more than half the women who wanted to have two children could only produce one child.³

A woman's fertility starts to decline in her 30s and this decline accelerates after her mid-30s. As Family Physicians we are seeing an increasing number of patients with subfertility or infertility issues. Historically, infertility has been defined as the failure to achieve pregnancy within 1 year of regular, unprotected intercourse. However, this definition does not take into account a woman's age, absence of regular ovulation eg. PCOS and other associated medical conditions such as endometriosis. Earlier evaluation and prompt intervention will be necessary in the race against time for fertility.

As Family Physicians we have to explore physical and psychological causes, male and female factors of fertility issues, but are we familiar with current treatment options and the regulations governing assisted reproductive technology (ART)? Rather than discussion of causes of infertility and definitive treatment, this article attempts to explore the ethical and legal aspects of ART.

At present, the Hospital Authority provides infertility treatment services at nine public hospitals to legally married couples aged under 40, mainly Artificial Insemination by Husband (AIH) and In-vitro fertilization (IVF). IVF treatment is available in three ART centres, namely Kwong Wah Hospital, Prince of Wales Hospital (PWH) and Queen Mary Hospital (QMH). The current subsidised charges for each IVF cycle range from \$4,000 to \$12,000. Self-financing patients can receive services offered by the two Universities at PWH and QMH, with shorter waiting times but at higher charges.

Of the existing 41 private licensed ART centres, 30 provide AIH treatment and 11 offer services such as sperm washing, IVF and embryo transfers. The estimated charges for one cycle of AIH range from \$8,000 to \$16,000 and packages for IVF procedures cost from \$65,000 to \$100,000.

All ART treatment is carried out under the regulations of the Council on Human Reproductive Technology. The Council which comprises of 22 non-official members (including the Chairperson) and 4 public officers appointed by the Secretary for Food and Health, under the delegated authority of the Chief Executive, was established under section 4 of the Human Reproductive Technology Ordinance (Cap. 561) in 2001 to regulate the provision of reproductive technology procedures,



the conducting of embryo research, the handling, storing or disposing of gametes or embryos used or intended to be used in connection with a reproductive technology procedure or embryo research, and surrogacy arrangement.

The Human Reproductive Technology Ordinance, passed in 1997, dictates that fertility treatment in Hong Kong can only be offered to heterosexual married couples. Other various ART treatment such as gamete storage also have specific legal requirements. This shuts the door for nontraditional families such as same sex couples or co-habiting couples. Non-married individuals have been going abroad to countries such as Thailand, Taiwan and the US, where fertility laws do not prohibit non married individuals, to obtain ART services. What most of us do not realize, that it is actually a criminal offence for non-married individuals to venture overseas for fertility treatments such as IVF and surrogacy etc. Punishment is a HK\$25,000 fine and six months imprisonment for the first offence. Sentences however have not been doled out in courtrooms due to various reasons including the lack of jurisdiction for overseas investigation. That legislation which was passed two decades ago could very possibly change as the Equal Opportunities Commission is undergoing a public consultation on the review of discrimination law.

Another emerging issue encountered amongst patients is the issue of fertility preservation. The most legitimate medical reason being patients on treatment such as anti-cancer treatment which may affect their fertility since the ovaries and testes are most sensitive to injury from medications, diseases, chemotherapy and radiation. "Fertility preservation" refers to strategies hoping to preserve the individual's hormonal function as well as fertility including sperm/oozyte or embryo freezing.

But what about unmarried women who are in their late 30s/early 40s planning to have children a few years down the road and wanting to increase their

chances with fertility preservation? In Hong Kong, non-married individuals can have their sperm or eggs frozen (after hormonal stimulation and surgical collection) for future use but clinics can't impregnate patients with those eggs unless the woman is married as well as providing a medically valid infertility issue to receive these procedures.

Although we are not ART physicians, as Family Physicians we also have a responsibility to reflect on the definition of the "Family" in the 21st century and face the numerous ethical challenges associated with it. Who can say a family consisting of same sex parents or a single parent through his/her own choice are inferior parents when compared to traditional families? Indeed some may be even better at parenthood. Ethical discussions include protection of the unborn embryo, respect for autonomy, the principle of beneficence and much more. The discussion floor is open and maybe one of the first things we have to do is to understand what the current legislations and regulations are in Hong Kong and apprehend what our patients are asking for.

Learning Points:

Dr. Lee started the talk with a brief review of the actions of anti-acne therapies of different group of medications, followed by treatment of acne.

Resistance to P.acnes to antibiotics is a global phenomenon with reduction of clinical response in acne patients. There are resistance issues in topical antibiotics than orals. Strategies for Limiting P.acnes Resistance from Global Alliance Recommendations (Endorse by AAD 2013): 1) Combine a topical retinoid with antimicrobial is rational choice; 2) Oral & topical antibiotics should not be used as monotherapy; 3) Concurrent use of oral & topical antibiotics should be avoided; 4) Limit the use of antibiotics to short periods and discontinue when there is no further improvement or improvement is slight; 5) Co-prescribe a benzoyl peroxide(BPO) containing product or use as washout; 6) Do not switch antibiotics without adequate justification; 7) Use topical retinoids for maintenance therapy, with BPO added for antimicrobial effect if needed.

Acne is often a long-lasting, chronic disease. For long-term acne therapy (maintenance therapy), topical retinoids, plus an antimicrobial agent if needed, are currently the best-studied and recommended agents.

Dr. Lee shared with us a study of common combination such as topical retinoids +topical antibiotics reported the best reduction of comedones after three months of therapy as compared to the monotherapy group.

BPO has primary antibacterial action with advantage of rapidly destroying P.acnes just in a few days, no

antimicrobial resistance and no decrease in efficacy over years of use. Third-generation topical retinoid BPO is the most logical combination of the available products with fast onset of action and tolerability similar to third-generation topical retinoid alone.
