Message from the President

As we went past the milestone of 100 days of COVID-19 vaccination programme implementation, the uptake rate of the vaccination could be described as lukewarm only. According to the recent official figures, the total number of doses administered was around 2.9 million, with 1.7 million of the total population given the first vaccine dose and 1.2 million given the second vaccine dose respectively.

Individuals may have doubts and worries about the COVID-19 vaccine. Family doctors provide comprehensive, continuing, holistic and personalised care to people in the community, looking after their physical, social and psychological aspects of health. People with chronic diseases, e.g., diabetes mellitus, hypertension, and those at advanced age have increased risks of morbidity and mortality from COVID-19 infection. The benefit of COVID-19 vaccination among those with clinically stable conditions generally outweighs the risk unless there is clear contraindication. (https://www. covidvaccine.gov.hk/pdf/Guidance_Notes.pdf) Recent experiences in other parts of the world show that a higher percentage of population vaccinated against COVID-19 can facilitate the return to normalcy. Vaccination against COVID-19 will not only protect oneself, but also one's family and friends, as well as the community. The Hong Kong Academy of Medicine together with the Hong Kong College of Family Physicians, the Hong Kong College of Paediatricians and the Hong Kong College of Obstetricians and Gynaecologists issued a joint statement on 26 May 2021 to further encourage the public to receive COVID-19 vaccination as soon as possible to help

the society moving towards resumption of our normal daily lives. (https://www. hkam.org.hk/sites/default/ files/20210526_Hong_Kong_ Academy_of_Medicine_ urges_the_public_to_get_ vaccinated_as_soon_as_ possible-EN_TC.pdf)



By the way, in the June issue of the Hong Kong Practitioner, Dr. Weng-yee Chin shared with us on the role of family doctors in addressing vaccine hesitancy, which is well worth reading.

On 1 June 2021, the World Health Organisation (WHO) validated the Sinovac CoronaVac COVID-19 vaccine for emergency use, giving countries, funders, procuring agencies and communities the assurance that it meets international standards for safety, efficacy and manufacturing. (https://www.who.int/news/item/01-06-2021-who-validates-sinovac-covid-19-vaccine-for-emergency-use-and-issues-interim-policy-recommendations) Therefore, with WHO's previous approval of Fosun/BioNTech Comirnaty vaccine, both locally available vaccines have now got the blessing by WHO for emergency use.

World Blood Donor Day aims at raising the awareness of the need for safe blood and blood products for transfusion and of the critical contribution voluntary, unpaid blood donors make to national health systems across the globe. World Blood Donor Day (WBDD) takes place on 14 June each year. For 2021, the theme of the WBDD is "Give blood and keep the world

beating" which highlights the crucial contribution of blood donors in keeping the world pulsating by saving lives and improving others' health.

FINAL REMINDER: Diploma in Family Medicine (HKCFP) 2021 - 2022

The Board is pleased to announce that the Diploma Course in Family Medicine (DFM) organized by The Hong Kong College of Family Physicians will commence in July 2021.

Training Funding Scheme for Primary Care Doctors by Primary Healthcare Office, Food and Health Bureau

The Food and Health Bureau has decided to reimburse \$5,500 for registered medical practitioners in Hong Kong who enroll in CCEFM or DFM 2021-2022 having satisfied the corresponding course requirements as an incentive to encourage more medical practitioners to join the related training.

The course consists of FIVE modules. Modules I & II will be delivered by Local Distance Learning. Modules III, IV & V consist of lectures, seminars, tutorials, workshops and clinical attachments. The whole course requires ONE year of part-time study.

Details of the course are as follows:

1. Objectives:

- i) To provide knowledgeable, pragmatic and structured teaching in Family Medicine for medical practitioners
- ii) To encourage professional development of practising medical practitioners and to provide an intermediate step to fellowship qualifications in Family Medicine
- iii) To improve standards and quality in the practice of Family Medicine

2. *Syllabus:

- The course consists of FIVE compulsory modules. Doctors who have graduated from the course are expected to have acquired:
- i) Current concepts about nature of Family Medicine
- ii) Knowledge and skills in consultation, counselling and problem solving
- iii) Knowledge and skills in common practice procedures and emergency care required for good quality family practice
- iv) Understanding of the role of Family Doctors as gatekeepers of the health-care system and in providing cost-effective primary care to the community

Contents:	Four compulsory and two elective Practical Workshops in selected areas including Advanced Primary Care Life Support (APCLS), Consultation Skills, Counselling Skills, Women's Health, Orthopaedic Injection and Musculo-Skeletal Medicine

*Modules III, IV and V would be scheduled on Saturday and Sunday afternoons.

3. Articulations:

The Course allows (up to a fixed maximum percentage of the Course units) articulations or cross recognition of previous Family Medicine training programmes that provide learning units equivalent to that of the above syllabus. Participants who wish to apply for such articulations have to submit evidence of relevant training together with their applications. The granting of articulations is however, completely at the discretion and decision of the Board of DFM.

4. *Schedule:

The whole course requires ONE year of part-time study.

*The schedule might be affected due to unexpected circumstances and the format might change to online platform if necessary. Announcement will be made in case there is a change of schedule and/or format.

5. Admission Requirement:

Medical Practitioner with Bachelor's Degree in Medicine.

6. Teaching Staff:

A panel of experienced academic medical professionals in Family Medicine, hospital specialists and experienced Fellows or Trainers of HKCFP will be invited to teach in the programme.

7. Teaching Medium:

English

9. Awards/Credits:

- i) A Diploma in Family Medicine issued by HKCFP will be awarded to candidates who have satisfied all the requirements and have passed all the required assessments and the Final Examination.
- ii) The Diploma is a **Quotable Qualification** of the Medical Council of Hong Kong.
- iii) Up to 50 CME and 10 CPD credit points will also be awarded to candidates upon satisfactory completion of the Course by the QA & A Committee of HKCFP.

10. Application Procedure:

Application is now open.

A completed application form must be returned to The Hong Kong College of Family Physicians with the following:

- i) Photocopy of the current Annual Practising Certificate;
- ii) A recent photo of the applicant (passport size);
- iii) A signed "Disclaimer of Liability";
- iv) An administration fee for application of HK\$1,000 by crossed cheque payable to "HKCFP Holdings and Development Limited". This fee is non-refundable:
- v) A Course Fee of HK\$38,000 (or HK\$76,000 for non-members) by crossed cheque payable to "HKCFP Holdings and Development Limited". This fee is non-transferable and non-refundable.

Every successful applicant will be notified by an official letter of admission.

HKCFP CERTIFICATE COURSE IN ESSENTIAL FAMILY MEDICINE 2021-2022

The HKCFP Certificate Course in Essential Family Medicine (CCEFM) is designed to meet the training needs of practicing primary care doctors who would like to refresh or update their clinical knowledge and skills relevant to Family Medicine practice. The curriculum of this course also forms part of the well-established HKCFP Diploma in Family Medicine (DFM) course. Our teaching faculty are experienced clinicians working in primary care, in secondary care and in academia. The course has been designed to enhance the course participants' competencies in daily Family Medicine practice in the community.

1. OBJECTIVES:

- i. To provide knowledgeable, pragmatic and structured training in Family Medicine for medical practitioners
- ii. To encourage professional development of practising medical practitioners
- iii. To improve standards and quality in Family Medicine practice by adopting holistic patient-centered care via an integrated care approach

2. SYLLABUS:

The CCEFM consists of THREE segments, including Modules III, IV (FM attachment + Update) and parts of Module V in the Diploma in Family Medicine (DFM). Doctors who have graduated from the CCEFM are expected to have acquired the following essential concepts and course contents:

- i. The role of Family Doctors particular in providing cost-effective primary care to the community
- ii. The essential knowledge and skills on common problems encountered in Family Medicine
- iii. Enhancement in the consultation and problem solving skills
- iv. Acquiring the knowledge and skills in common practice procedures related to family practice

3. AWARDS/CREDITS:

- i. After completion of all the components and course requirements (max. within TWO years), a certificate will be awarded to the successful candidates
- ii. The completed modules and credits can be accredited towards the quotable HKCFP DFM course, if the candidates would like to enroll into DFM course subsequently
- iii. 25 CME and 5 CPD credit points will also be awarded by HKCFP.

Dear College Members,

RE: MCHK CME Programme for Practicing Doctors who are not taking CME Programme for Specialists *(Ver. May 2021)*

We are pleased to remind you that our College members who are registered with Hong Kong Academy of Medicine (HKAM) as their MCHK CME administrator via HKCFP will have their associated administrative charge waived starting from January 2017. For members who would like to **register/switch** their MCHK CME Administrator to HKAM via the College (with current cycle start date 1 July only) **starting from 1 July 2021, they MUST submit Registration Consent Form** to College Secretariat before **30 June 2021 (Wednesday)**.

Interested members who are currently not registered with HKAM should note the follows:

- 1. Doctors must be register under one of the CME administrators, in order to be enrolled in the MCHK CME programme (Please refer to https://www.mchk.org.hk/english/cme/files/Frequently_Asked_Questions.pdf) for more details)
- 2. HKCFP Members are **NOT** automatically registered with Hong Kong Academy of Medicine (HKAM) via HKCFP as their MCHK CME administrator; unless Registration Consent Form is submitted for further enrolment process.

(HKCFP Members are enrolled in HKCFP QA programme only, which is a different CME programme)

- 3. MCHK registrants (with current cycle start date **1 July**) will have to liaise with their current CME Administrator (HKMA, DU, DH) for the necessary procedures in relation to change of the CME Administrator.
- Change of CME Administrator from 'other CME Administrator' to 'HKAM via HKCFP' can be arranged after ONE Cycle Year of programme has completed, given that HKAM was not the administrator of your previous MCHK CME Cycle.
- 5. Overseas Conferences: please submit Attendance Record within one month on completion of the conference.
- 6. Self-study: please submit details of the programme within one month on completion of the Self-study.
- 7. Retrospective submission cannot be accredited outside the said time frame. In case of any discrepancy of accredited CME Points between HKCFP and 'other Administrators', the HKCFP has the final decision on the final accredited CME Points.

As our College is required to report the CME Points to HKAM every 6 months, MCHK CME registrants **MUST** sign on the respective MCHK CME attendance record sheet for CME record purposes. **To help the College Secretariat to distinguish College members from others, please identify yourself by entering your HKCFP membership number or simply putting "HKCFP" in the column of HKAM**. MCHK CME record may not be updated if one fails to update MCHK CME Administrator in a timely fashion.

The above arrangement is for our College members only. The required Registration Consent Form can be downloaded at www.hkcfp.org.hk Downloads > 'Quality Assurance & Accreditation'. Please return the completed form to our College Secretariat at cmecpd@hkcfp.org.hk before the captioned deadline to facilitate the necessary arrangement. HKCFP Trainees Research Fund 2021 / HKCFP Research Seed Fund 2021

The Research Committee of HKCFP is pleased to continue to offer the two research funds, The Trainees Research Fund and the Research Seed Fund.

The Trainees Research Fund will be opened to all registered HKCFP trainees and is made of four awards (each up to HK\$10,000). It is envisaged it will help trainees especially (but not limited to) those doing research projects at their exit examinations. Those who have funding support elsewhere will not be considered.

The Research Seed Fund is open to all HKCFP members where a maximum of HK\$25,000 award will be made to the successful applicant to assist the conduction of a research project.

Winners of the award will receive 50% of the approved grant up front and the remainder 50% upon completion of the project.

Please note that each applicant can only apply either one of the above Funds

Assessment Criteria for both funds:

- 1. Academic rigor of the research project (e.g. originality, methodology, organisation and presentation);
- 2. Relevance and impact to family medicine & primary care (e.g. importance of the topic and the impact of the findings on the practice or development of the discipline); and
- 3. Overall budget

C-reactive protein (CRP) is an acute phase protein, synthesized in the liver, involved in the activation of complement, enhancement of phagocytosis, and detoxification of substances released from damaged tissue. It is one of the most sensitive (albeit nonspecific) indicators of inflammation. CRP levels may rise within six hours of an inflammatory stimulus. Measurement of CRP concentrations by this highly sensitive method is performed primarily to ascertain the level of cardiovascular disease risk in individuals who have no existing inflammatory conditions. Increases in CRP concentration are non-specific and should not be interpreted without a complete medical history.

There are two indications for use:

- 1. Assessment of risk of developing myocardial infarction in patients presenting with acute coronary syndromes
- 2. Assessment of risk of developing cardiovascular disease or ischemic events in individuals who do not manifest disease at present

High-sensitivity CRP (hs-CRP) is more precise than standard CRP when measuring baseline (ie, normal) concentrations and enables a measure of chronic inflammation.

Atherosclerosis is an inflammatory disease and hs-CRP has been endorsed by multiple guidelines (including 2019 ACC/

AHA Guideline on the Primary Prevention of Cardiovascular Disease) as a biomarker of atherosclerotic cardiovascular disease risk.


A large prospective clinical trial demonstrated significantly less cardiovascular risk for patients with hs-CRP less than 2.0mg/L. More aggressive treatment strategies may be warranted in patients with hs-CRP of 2.0mg/L or higher.

C-reactive protein (CRP) is an acute-phase reactant and has high intra-individual variability. Therefore, a single test for high-sensitivity CRP (hs-CRP) may not reflect an individual patient's basal hs-CRP level. Repeat measurement may be required to firmly establish an individual's basal hs-CRP concentration. The lowest of the measurements should be used as the predictive value.

Because CRP is an acute-phase reactant, measurements in apparently healthy individuals may not truly reflect the basal level if inflammation is present.

Significantly decreased CRP values may be obtained from samples taken from patients who have been treated with carboxypenicillins.

HsCRP could identify patient groups who may benefit from more aggressive guideline-based treatment of risk factors, helping patient discussions to encourage lifestyle changes to reduce their inflammation.

Community Vaccination Centre: Trump Card to End COVID-19 Pandemic

Dr. Chan Yuen Ching, Dr. Lo King Yan Cathy and Dr. Ng Yeung Shing (Family Physicians in New Territories West Cluster, Hospital Authority)

To protect Hong Kong citizens against COVID-19, a territorywide COVID-19 Vaccination Programme which was free of charge and on a voluntary basis, was set up for all Hong Kong residents by the Government in March 2021. The Government had set up 29 Community Vaccination Centres (CVC) in eighteen districts in Hong Kong.

Being Family Physicians, we have an important role to safequard public health and to beat COVID-19 pandemic. A team of doctors in Department of FM and Primary Health Care of NT West Cluster had joined as team members in Yuen Long Community Vaccination Centre by working outside their normal working hours under voluntary basis.




The venue for Yuen Long CVC is transformed from Yuen Long Sport Centre originally. The transformation was supported by Civil Service Bureau (Coordination and Administrative support) and Leisure & Cultural Services (Site support). The planning and work flow design of Yuen Long CVC were prepared by a committed multidisciplinary team led by senior doctors, nurses, and pharmacists in New Territories West Cluster in Hospital Authority.

The venue of CVC is divided into different designated work areas with adequate spacing. Some restricted areas, which could only be accessed by authorized persons, are arranged for vaccine dilution and storage of vaccine, medical consumables and clinical wastes.

The venue of CVC is well lit, ventilated and clean. The patientflow, material-flow and staff-flow are well designed so that good efficiency could be achieved. Hence, the maximum estimated attendance of a CVC could be around 2,500 doses per day.

Donning/Doffing Area

Service hours of CVC start from 08:00 to 20:00 with an hour of lunch break at 13:30. The main role of the doctor is to provide emergency support for handling adverse reactions and also potential accidents / injuries in CVC. Doctors also assist to handle enquires referred by nurses. Equipment for emergency care are available, including resuscitation equipment (Emergency airways, Ambu bag, oxygen, suction device, iv fluid, automated external defibrillator). Infection Control gears including PPE and IQ Air are in place for the protection of our health care workers.

As doctor-in-charge, we are responsible for management of patient conditions inside CVC. We have to keep ourselves upto-date on the management of all possible clinical problems arising from COVID-19 vaccine, including anaphylaxis. Common problems encountered in the sick bay include vasovagal syncope, a spectrum of allergic reactions (skin rash, urticaria, angioedema etc.), chest pain, dizziness or palpitation after vaccine injection, and a range of neurological symptoms such as limb numbness. Initial assessment by doctor-incharge will be conducted. Available drug treatments in the sick bay include IM piriton, Ventolin inhaler and IM 1:1000 adrenaline which is reserved for anaphylaxis. If patient's condition could not be settled by the initial management, patients may be referred to emergency department for further stabilization. Timely liaison and communication with the team of regional hospital Casualty, Central Medical Team of Department of Health and hospital administration by doctor incharge is essential to ensure proper hand-over of patient care and dissemination of the necessary information.

Within the team of Community Vaccination Centre, Family Physicians have played a role to achieve important goals to fight the virus, to protect our Hong Kong citizens, to revert our social life back to normal and to restart the economy.

Sharing of Experience by Dr. Chan Yuen Ching, Higher FM Trainee, New Territories West Cluster

Health promotion and prevention of disease are critical and foundational components of primary care and family medicine. As a higher trainee in Family Medicine, it is my honor to participate in this tertiary-wide vaccination programme. In the past year, COVID-19 has brought about many suffering to Hong Kong citizens. Vaccination programme is the light at the end of the tunnel, providing effective and reliable way to help our society return to its norm. In the community vaccination centre, I would ensure citizens' safety and handle enquiries related to contraindication of COVID-19 vaccine. My key duty was to manage any side effects or minor ailments after vaccination, exercising the role of gatekeeping as a family physician. Most clients recovered after rest and reassessment. Many of them volunteered anxiety symptoms after vaccination especially after reading the news. I learnt that the role of doctor in reassuring the patient was very important in handling their misbeliefs and anxiety towards COVID-19 vaccine.

After working in CVC, I understand more about citizens' worries on vaccine side effects. I would be more confident to counsel patients on COVID-19 vaccination in my daily work in General Out-Patient Clinic. I hope that via the promotion and encouragement by family doctors, the COVID-19 vaccination rate in Hong Kong would climb up to achieve a herd immunity to combat the COVID-19 virus.

Sharing of Experience by Dr. Lo King Yan Cathy, Basic FM **Trainee, New Territories West Cluster**

The outbreak of COVID-19 has caused extensive causalities worldwide and affected our daily life to a great extent for more than one year. With the arrival of COVID-19 vaccines, the battle against coronavirus will hopefully be put to an end soon. It is my pleasure to take part in the COVID-19 vaccination campaign through working in CVC. During my shift, I was mainly on standby in case of any medical contingency. Given the presence of experienced nurses from all main specialties, most enquiries from the patients have been promptly dealt with without doctor intervention. Patients in need will be brought to sick bay immediately for consultation while their vitals will be taken by a nurse. I have encountered cases including hypertension, palpitation after vaccination, dizziness, skin rash and anxious patients. Most patients were discharged directly after observation except one with persistent palpitation. Occasionally, I would provide detailed information about COVID-19 vaccines to patients, and in doing so I helped to dispel misunderstanding about the vaccination.

Having worked in CVC, I am pleasantly surprised to witness that the vaccination campaign indirectly promoted health awareness of Hong Kong citizens. For example, I have learnt that many hypertensive/ diabetic patients have been diagnosed recently through pre-vaccination metabolic screening. I am hopeful that the ongoing progress of the vaccination campaign will contribute to raise the overall health consciousness among Hong Kong citizens.

馬丘比丘、彩虹山

Dr. Chan Shan Ching (Specialist in Family Medicine)

秘魯,一個給人感覺很神祕的國度,這是我第一個到訪的南美國家。二零一九年十一月初跑完 紐約馬拉松,去了這個充滿熱情的拉丁美洲國家一個星期,到了古都庫斯科和首都利馬,此行 的最主要景點是位於庫斯科附近的馬丘比丘和彩虹山。

馬丘比丘



馬丘比丘, 位於庫斯科附近的一座山城, 它建築於 大約2400米高的山上, 位置極為隱密, 它是印加帝 國遺留下來的一個古蹟, 大概建於500多年前, 當 時是十五至十六世紀(1438-1533), 印加帝國是當 時美洲最大的帝國, 橫跨現時南美的秘魯、厄瓜多 爾、哥倫比亞、玻利維亞、智利及阿根廷。

在印加帝國滅亡之後,遺下的古蹟絕無僅有,加上 當時沒有什麼文字記錄,所以這座古城遺址成為了 研究印加帝國文化歷史的重要史跡。

由於位置隱密,它在一百多年前才被發現,自此成 為歷史文化遺產,同時亦被選為新世界七大奇蹟。 這座城的建築以石塊為主要架構,石與石之間緊密 地接合在一起,連成堅固的城牆。要在這個位高 二千多米的山上,建築一座這樣具規模的城,究竟 是怎樣建立而成,到現在還是一個謎。

一般認為,這座城的建造,主要是提供當時的皇室 貴族成員作為靜修的居所。選址除了考慮到遠離繁 忙的城市之外,同時亦是一個安全的地方,加上位 於高處亦易於監察有沒有外來的入侵。

彩虹山



彩虹山是近年才新興的景點,記得有一次在機上雜 誌上見到它的介紹,就被那充滿多元色彩的山深深 吸引。它位於距離古城庫斯科約三小時的車程,到 了入口處,還要經過一段位於五千多米高度的山 路,五公里的路程大概要走一、兩個小時,大部分 山路不算崎嶇難行,不過在五千幾米的高度行走, 一定會有氣喘的感覺,最後一小段要攀上一個很陡 峭的小山上,就可以看到這座色彩豐富的山了。

彩虹山的多彩,是由於不同的礦物元素沉澱而成, 在陽光照耀下,產生出層出不窮、色彩多變的豐富 色彩。它是幾年前才被發現的,由於全球暖化,將 冰雪溶化,所以才將這個埋藏在雪下的山色得見天 日,呈現出來。 HKCFP
