WONCA Asia Pacific Regional Conference 2025 would take place from 24 – 27 April 2025 plus the Young Doctor Pre-conference on 23 April 2025 in Busan, Korea.

Reminder: Submission of Annual Checklist for Basic Training

To all Basic Trainees.

Interested members who are currently not registered with HKAM should note the following:

- 1. MCHK registrants will have to liaise with their current CME Administrator (HKMA, DU, DH) for the necessary procedures in relation to change of the CME Administrator.
- 2. Change of CME Administrator from 'other CME Administrator' to 'HKAM via HKCFP' can be arranged after **ONE Cycle Year of programme has completed**, given that HKAM was not the administrator of your previous MCHK CME Cycle.
- 3. Retrospective submission cannot be accredited outside the said time frame. In case of any discrepancy of accredited CME Points between HKCFP and 'other Administrators', the HKCFP has the final decision on the final accredited CME Points.

As our College is required to report the CME Points to HKAM every 6 months, MCHK CME registrants **MUST** sign on the respective MCHK CME attendance record sheet for CME record purposes. **To help the College Secretariat to distinguish College members from others, please identify yourself by entering your HKCFP membership number or simply putting "HKCFP" in the column of HKAM. MCHK CME record may not be updated if one fails to update MCHK CME Administrator in a timely fashion.**

With cycle year 2024 is going to be finalized, please kindly check your updated report by visiting the College website at https://www.hkcfp.org.hk/cme_mchkcme_report.aspx (Membership login is required)

The committee wishes to highlight that all fellows and members of HKCFP must engage in ALL categories of activities in order to fulfill the QA Certificate 2023-2025 criteria, briefly summarized as follows:

- (1) A minimum of 90 points in total, including at least 30 CPD points
- (2) A maximum of 45 credit points will be counted for each category of educational activities
- (3) Participants must engage in **ALL** categories of activities
- (4) Maximum points set for Subcategories (3.01, 3.02, 3.03a-c, 3.04, 3.09, 3.10)

For Point (2) and (3) above, the 'categories' are referring to

- i) Category 3, related to CPD activities,
- ii) Category 4, related to activities organized by our College alone, and
- iii) Category 5, related to pre-accredited activities organized by other professional institutions themselves or in collaboration with our College. Examples of this category include accredited educational events by the Hong Kong Medical Association, The Universities, the Hospital Authority, and the Primary Care Office / Department of Health.

Smart Hub

The Family Medicine Department of the New Territories East cluster (NTEC FM) has launched a pilot programme known as the "Smart Hub" (健康小屋) since Feb 2023. This programme aims to provide remote care services to rural areas through telemedicine and medico-social collaboration.

The motivation behind developing the "Smart Hub" stems from the challenges faced by elderly populations residing in remote villages. These individuals often struggle to travel to clinics for medical consultations and regular follow-ups, as it involves long and tiring journeys, often requiring the assistance of family members. While the Hospital Authority provides floating clinic (醫療船) and traveling dispensary (醫療車) services that visit certain remote areas, the services and reach are limited, and patients still need to visit the clinic for medication collection. The COVID-19 pandemic had further affected these services, necessitating a new and better solution for remote healthcare.

To address these challenges, the "Smart Hub" programme was conceived as a collaborative effort between the Hospital Authority (HA) and local Non-Government Organizations (NGOs). To establish the "Smart Hub" programme, three main elements are required, first of all, a village house, Wifi connection and patients with chronic illnesses. Our team identifies a common gathering place in each remote village, such as the village house (村公所), which serves as the "Smart Hub". Next, we would test network connectivity. Once both site and network connectivity are available, our team would start identifying suitable chronic illness patients from North District General Outpatient clinics (GOPCs) for telehealth services.

One most important step before launching the "Smart Hub" programme is local engagement. The HA team will work with local NGOs to introduce the aim and workflow of the "Smart Hub" programme to village chiefs and residents. (photo 1)

To facilitate the operations of medical consultations, portable remote medical instruments, including blood pressure monitors, oxygen saturation monitors, electrocardiograms, and stethoscopes, are equipped at the "Smart Hubs" (**photo 2**). With the technical support from our collaborative partner, remote telemedicine consultation services can be conducted at these lively "Smart Hubs."

Tsiu Keng Village (蕉徑村) is our first Smart Hub in this pilot programme and eight patients were recruited. These patients regularly visited the GOPCs for follow-up consultations for chronic diseases such as hypertension and diabetes. The participants, with an average age of 78 and the oldest being 86, received patient empowerment education activities at the "Smart Hub" (village house) conducted by the District Health Express of North District (北區地區康健站) (photo 3). This education aimed to

enhance their understanding of their medical conditions and equip them with the knowledge and skills to utilize the telemedicine tools, including the HA Go apps. After completing the course, these patients had their first teleconsultation follow-up with doctors from the NTEC FM on 22 Feb 2023. The outreach service team from The Hong Kong Young Women's Christian Association (YWCA) provided on-site technical support at the village house to facilitate the teleconsultation.

During the teleconsultation at the "Smart Hub", nurses and staff from the local NGOs assisted the patients in registration and payment through the HA Go apps, as well as operating the telemedicine devices (photo 4). Family Medicine doctors from the Fanling Family Medicine Centre conduct video consultations with patients (photo 5). The doctors can access data from the remote medical devices, such as blood pressure and heart rate, and utilize the remote stethoscope to listen to heartbeats and breath sounds. Privacy is ensured with partitions at the village house. After the consultation, patients can simply return home. The pharmacist from the Hong Kong Pharmaceutical Care Foundation (HKPCF), another NGO, coordinates the delivery of medications to the "Smart Hub" the following day, providing medication counseling to the patients (photo 6).

The feedback from patients regarding the services provided at the "Smart Hub" has been overwhelmingly positive. They find the follow-up consultations at the "Smart Hub" more convenient, eliminating the need for family members to accompany them to the GOPC. Building upon the success of the pilot program, the "Smart Hub" remote care services have expanded to other rural areas in the North District and some outlying islands such as Kat O, Tap Mun, and Ko Lau Wan. As of May 31, 2024, 38 remote villages have been recruited into the project, with more than 180 patients having received at least one teleconsultation.

Patients enrolled in the "Smart Hub" program have remote follow-up consultations every 16 weeks. They also have an annual in-person consultation at the clinic for physical examination and blood tests.

In North District and outlying islands, many residents in remote villages are elderly with chronic illness. Looking ahead, the "Smart Hub" programme aims to continue expanding its coverage to enhance patient care in remote areas. Not only does it provide convenience to patients, it also helps to strengthen the self-management capabilities of patients with chronic illnesses through medico-social collaboration. Ultimately, this integrated approach aims to reduce the burden on the healthcare system while improving the overall well-being of the residents in these rural areas.

Beyond Stones: Importance of POCUS in Exploring Non-calculus Causes of Obstructive Nephropathy


Deranged renal function is very commonly encountered in general practice. By level of pathology, it is classified into pre-renal, intra-renal and post-renal.

Post-renal renal failure, also known as obstructive nephropathy, refers to ischemic injury of the kidney due to raised urinary tract pressure and reduced renal perfusion.

The urinary tract is composed of the renal pelvis, ureter, urinary bladder and the urethra. Obstruction at any one of these locations can result in obstructive nephropathy.

The cause of urinary tract obstruction can be due to calculus or non-calculus. KUB X-ray can detect at most 90% of the urinary calculus with artificial intelligence (AI) assistance and can help clinicians to diagnose and manage the obstruction early. However, non-calculus obstruction cannot be detected by KUB X-ray. This hinders the diagnosis of the obstructive nephropathy. In primary care setting, this gap could be filled with the use of Point-of-care Ultrasonography (POCUS). Here we would like to report 4 cases of non-calculus obstruction at different levels of urinary tract (**Figure 1**).

Case 1: Pelvi-ureteric junction (PUJ)

A 61-year-old man was presented with microscopic hematuria and blood result eGFR 45 mL/min/1.73 m², which was static for some time. There was no gross

hematuria or loin pain reported. KUB did not show any radiopaque lesion suggestive of calculus.


POCUS was performed which showed hydronephrosis of the left kidney. There was an echogenic tumor occupying the left renal pelvis, PUJ and the proximal ureter causing the obstruction (**picture 1**).

When we scanned the urinary bladder, we found that ureteric jet of urine was only present at the right ureterovesical junction under color Doppler. It signified left upper urinary tract complete obstruction. (**picture 2**)

Picture 2. Absence of ureteric jet at the left VUJ




On further investigation, urine cytology showed highgrade urothelial carcinoma. Contrast computed tomography (CT) scan confirmed left hydronephrosis was due to transitional cell carcinoma (TCC) at the left ureter (**pictures 3,4**). CT scan also showed the presence of bone metastasis to spine and right proximal femur.

Case 2: Ureter

A 62-year-old woman received follow-up for her hypertension and proteinuria at our clinic. She had history of attending the Emergency Department for uterine prolapse in 2023 and the first gynaecologist appointment will be in December 2024.


She was noted to have significant decline in eGFR from 67 to 28 mL/min/1.73 m² over one year, alongside a rebound in urine protein-to-creatinine ratio from 0.71 to 2.45. POCUS was performed in October 2024. There was no obvious masses or stones at the kidney but prominent bilateral hydronephrosis with hydroureter was observed (**pictures 5,6**). The bladder wall was smooth, without mass or chronic obstructive changes. After micturition, the residual urine volume of bladder was normal (20ml) (**picture 7**).

Upon further inquiry, the patient reported difficulty in urination, particularly in upright position, due to uterine protrusion from introitus over the past year. A grade 4 uterine prolapse (approximately the size of a fist) was observed during the physical examination (**picture 8**). She was urgently referred to urologist and the gyanecology appointment was advanced for further intervention.

POCUS CORNER

From studies, the prevalence of hydronephrosis in uterine prolapse ranges from 3.5% to 30.6%. Uterine prolapse causes herniation of the bladder, uterus, and ureters through the pelvic floor, leading to compression of the ureters between the fundus of the uterus and the bladder. Additionally, the stretching of the ureters can hinder peristaltic movement of smooth muscles, resulting in bilateral ureteric obstruction.

Case 3: Vesicouretric junction (VUJ)

This 87-year-old man received regular follow-up for his diabetes, microalbuminuria, hypertension and hyperlipidaemia. During annual assessment, he was found to have eGFR dropping from 65 to 43 mL/min/1.73 m² within a year. He did not have any urinary symptoms or abdominal pain. KUB X-ray was done and did not show any stone. POCUS was performed, showing unilateral left hydronephrosis with hydroureter (picture 9).

Further down the urinary tract at the bladder, a large tumor growing from bladder wall was seen (**picture 10**). Under color Doppler, it had increased vascularity (**picture 11**). The tumor caused obstruction of the left VUJ and hence absence of left ureteric jet (**picture 12**).





CT scan of abdomen and pelvis confirmed that left hydronephrosis (**picture 13**) and hydroureter was caused by a bladder tumor (size $4.5 \times 6.3 \times 4.9$ cm) involving the left VUJ (**picture 14**).


Case 4. Prostatic urethra

This 85-year-old gentleman presented with progressive worsening of eGFR from 75 to 52 mL/min/1.73 m² for 1.5 years. Urine culture was negative. He did not complain of urinary symptoms. POCUS performed showing bilateral mild to moderate hydronephrosis with hydroureter (pictures 15,16). There was no lesion or stone seen in both kidneys and ureters. Bladder was distended with multiple trabeculation (pictures 17,18). Prostate was enlarged with measured volume of 52cc (picture 19). Urinary ureteric jet was present bilaterally. He was referred to Urology clinic urgently for further management. Before urologist appointment, he developed acute retention of urine and was admitted to hospital. Trans-rectal ultrasound (TRUS) of prostate measured size 63cc. Proscar was prescribed to the patient while he was waiting for transurethral resection of the prostate (TURP) for benign prostatic hyperplasia.



Conclusion

Obstructive nephropathy accounts for 10% of all causes of acute and chronic renal failure (up to 20% in elderly with acute renal failure). It is not uncommon and should be considered when there is progressive drop in renal function. There is high level of suspicion if: 1) The drop in renal function is sudden and rapid. 2) The deterioration of renal function cannot be explained by other medical conditions e.g. chronic disease, glomerular cause or proteinuria.

POCUS CORNER

This case series collection demonstrates the utility of POCUS in primary care setting in early detection of dilatation of urinary tract (hydronephrosis and hydroureter) resulting from obstruction at different levels, and in revealing the underlying pathology.

The above cases underscore two important conditions: bilateral hydronephrosis and tumor obstruction. These conditions are more hidden as well as more serious compared with a single renal stone complicated hydronephrosis. Timely detection of these conditions can reverse the situation and save lives.

Statin Induced Necrotizing Autoimmune Myopathy (SINAM)

As a family doctor, we all know about the side effects of statin including myalgia, dyspepsia, rhabdomyolysis and deranged liver function, etc. Nearly all, if not most, of your patients with multiple comorbidities will be taking statin as one of the chronic medications.

A 65-year-old male presented to general outpatient clinic with deterioration of liver function and proximal complained of recent weight loss muscle weakness in 1-2 weeks. He also complained of recent weight loss. He had regular follow up in medical outpatient clinic for deranged liver function, fatty liver and hyperlipidemia. He had difficulty in climbing up stairs and combing of hair. He was a non-smoker and non-drinker. He was on atorvastatin 20mg daily for 3 years with no change in dosage. He was not taking traditional Chinese medicine and he had no known hepatitis. He was sent to hospital for suspected myasthenia gravis and worsening liver functions.

Upon investigations, CK was raised to above 20,000IU/L. Differential diagnoses include statin related myositis, polymyositis or dermatomyositis. The result was negative for anti-ACHhR antibody. CK level did not decrease despite discontinuation of statin. Finally antibody testing showed positive anti-HMGCR and his diagnosis of SINAM was made.

SINAM was very rare with incidence of 2-3 per 100,000 people treated with statins. This myopathy is characterized

by progressive loss of muscle strength even after discontinuation of statin.

Concerning the epidemiology, male is more commonly affected than female. Atorvastatin was most likely to be associated with SINAM. This kind of myopathy can develop several years after statin exposure. Most common symptoms will be muscle weakness, followed by myalgia, dysphagia and weight loss. Pattern of weakness usually affect upper and lower limbs and severity of weakness usually was moderate to severe. CK level, positive anti-HMGCR and muscle biopsy help the diagnosis of SINAM.

Main stay of treatment includes immunosuppressants and discontinuation of statin. For our patient, he was treated with two courses of IVIG and his condition is improving.

For Best Trainee Research Paper:

- 1. The principal investigator has to be a trainee of the Hong Kong College of Family Physicians, or within 3 years of completion of vocational training.
- 2. For higher trainees who are submitting their Exit Examination research project for this award, they must have submitted their project to the Specialty Board and have passed the research segment of the Exit Examination.
- *3. The research must be original work of the investigator(s).*
- 4. The research should have been conducted in Hong Kong.
- 5. The research must have been completed.
- 6. The paper should be presented under the standard headings of Abstract, Introduction, Methodology, Results, Discussion and Conclusion. References should be listed in full at the end in Vancouver format.

Assessment Criteria:

- 1. How relevant are the topic and findings to Family Medicine?
- 2. How original is the research?
- 3. How well is the research designed?
- 4. How well are the results analyzed and presented?
- 5. How appropriate are the discussion and conclusion(s) drawn?
- 6. How useful are the results for patient care in the discipline of Family Medicine?
- 7. How much effort is required to complete the research study?

Highlights from the WONCA APR Conference 2024: The Art & Science of Family Medicine

The WONCA Asia Pacific Region conference, held at the Raffles City Convention Centre in Singapore from August 21-24, 2024, embraced the theme "The Art & Science of Family Medicine," showcasing the multifaceted nature of family medicine. I had the privilege to join this amazing conference, connecting with family doctors from different parts of the region.

A standout feature of the conference was the TRM (The Rajakumar Movement) pre-conference tailored for young doctors. The Rajakumar Movement is the young doctor movement of the Asia Pacific Region. I was invited to deliver a welcoming speech at the TRM preconference and I shared some insights on preventing physician burnout. WONCA President A/Prof. Karen Flegg, delivered a workshop on the theme of planetary health. This session sparked engaging discussions on how to make clinical practices more sustainable and reduce the healthcare sector's carbon footprint. Young doctors representatives from various countries shared innovative ideas and strategies, enriching the dialogue around sustainable practices in family medicine. It was inspiring to witness the collaborative spirit as participants explored actionable steps that can be implemented in their respective countries.

Prior to the conference, I had an amazing experience exploring Singapore's healthcare system during a preconference visit. Our first stop was Punggol Polyclinic, a prime example of a comprehensive primary care center. This community-based polyclinic covers acute illness, chronic disease management, and preventative care, all

well-supported by allied health services. One standout feature is their innovative pillbox service, which facilitates medication collection outside of working hours—this game-changing initiative can significantly shorten wait times at the pharmacy and improve patient flow efficiency.

Next, we visited Sengkang Community Hospital, which specializes in helping patients recover from acute hospital admissions. Their rehabilitation programs are impressive, focusing on aiding individuals in regaining strength and independence, thus preparing them for a smooth transition back home. Each patient is assigned a social prescriber to help them reconnect with their community, enhancing overall recovery and well-being. Singapore's commitment to a robust primary care backbone and a family medicine-centered approach is truly inspiring, utilizing only 4% of their GDP while maintaining a patient-centered and cost-effective system.

During the conference, I was honored to present my exit research topic, a qualitative study on the facilitators and barriers of breastfeeding among primary healthcare workers. This opportunity allowed me to discuss the critical role of family medicine doctors in promoting breastfeeding with colleagues from Japan, Australia, and Indonesia. Our conversations underscored the importance of supporting new mothers and enhancing breastfeeding practices within the community.

Another notable workshop was organized by the Special Interest Group on Family Violence (SIGFV), which focused on identifying and addressing family

violence within the context of primary care. Participants including family doctors and social workers engaged in dynamic discussions about the signs of family violence and the importance of a multidisciplinary approach in managing such cases. The workshop emphasized strategies for protecting patients who may be under threat or in vulnerable situations. Attendees shared best practices for creating safe environments where patients feel empowered to disclose their experiences. This collaborative dialogue reinforced the critical responsibility of family medicine practitioners to recognize and respond effectively to family violence, ultimately fostering a more supportive and protective healthcare atmosphere for those in need.

A special memorable event of the conference was a lively cocktail party and karaoke celebration, generously hosted by the Singapore College of Family Physicians. This enjoyable event provided an excellent platform for networking, allowing attendees to forge new friendships and strengthen existing connections.

Overall, I was truly grateful for the opportunity to attend the WONCA Asia Pacific Region conference in Singapore, merging the art and science of family medicine with cultural celebration. It not only reinforced the bonds within the family medicine community but also propelled discussions on sustainability and the vital role of family practitioners in promoting health and well-being across diverse populations.


