# Message from the President

The Health Bureau and the Hospital Authority announced a plan to reform public healthcare fees at the end of March. (https://www.info.gov.hk/gia/general/202503/25/P2025032500462.htm) The Hong Kong College of Family Physicians (HKCFP) supports the direction of the plan and believes that the measures proposed in the plan can guide patients to appropriate healthcare services, rationalise the current imbalance in public healthcare services, enable different healthcare service providers to care for patients in their respective positions, promote the development and improve the quality of Hong Kong's healthcare services in the long run, and enable Hong Kong to continue to maintain its leading position in the international medical community.

This public healthcare fees reform targets the abovementioned service mismatch issues and effectively directs patients to appropriate healthcare services for the appropriate treatment. The reform is in line with the "Primary Healthcare Blueprint" and "Chronic Disease Co-Care Pilot Scheme" formulated by the Health Bureau to meet the challenges of population aging and rising rates of chronic diseases, comprehensively improve the health of citizens, and strengthen protection for patients.

Through this reform, it is anticipated to change the misconception among patients that the emergency room or specialist outpatient clinics is the gateway to healthcare services. In fact, family doctors are the first point of contact for patients to receive healthcare services. In recent years, we have been actively

promoting the concept of "family doctor for all" in the hope that patients can first be screened by their family doctors before considering the needs for receiving specialist or other further medical



services. Family doctors are familiar with and have a clear understanding of the patient's condition. They can provide patients with appropriate medical assessment and advice first. Appropriate health issues can be handled directly by the family doctor, and the patient will be referred to relevant specialists for follow-up when indicated. This division of labour, collaboration and stratified medical model not only ensures that patients receive appropriate treatment directly, but also improves the treatment outcome.

One of the important directions of this public healthcare fees reform is to guide non-emergency patients from the emergency room back to primary healthcare services, so that family doctors can take care of these patients. The Hong Kong College of Family Physicians believes that this reform direction would help to reverse the undesirable phenomenon in the past where patients went directly to the emergency room for treatment without effective triage based on the severity of their condition, and can also promote the development of primary healthcare services.

The HKCFP supports the direction of reform and hopes that these reform measures can be implemented as soon as possible to further promote the sustainable development of Hong Kong's healthcare services. As family doctors, we will continue to educate patients through different platforms and work with the government to promote the development of family medicine and "family doctor for all". The HKCFP will also continue to support family doctors' training and continuing professional development so that family doctors can continue to provide quality services to the public.

World Family Doctor Day (WFDD) falls on the 19<sup>th</sup> May each year. This year's theme, "Building Mental Resilience in a Changing World", draws attention to the vital contributions made by family doctors in nurturing mental health and fostering resilience during these rapidly changing and challenging times. In recognition of the pivotal role family doctors play within our communities, the Hong Kong College of Family Physicians, in collaboration with the Primary Healthcare Commission of the Health Bureau, is hosting a WFDD 2025 Symposium on 17<sup>th</sup> May at the HKAM Jockey Club Building. # **HKCFP CERTIFICATE COURSE IN ESSENTIAL FAMILY MEDICINE 2025-2026**

The HKCFP Certificate Course in Essential Family Medicine (CCEFM) is designed to meet the training needs of practicing primary care doctors who would like to refresh or update their clinical knowledge and skills relevant to Family Medicine practice. The curriculum of this course also forms part of the well-established HKCFP Diploma in Family Medicine (DFM) course. Our teaching faculty are experienced clinicians working in primary care, in secondary care and in academia. The course has been designed to enhance the course participants' competencies in daily Family Medicine practice in the community.

### 1. OBJECTIVES:

- i. To provide knowledgeable, pragmatic and structured training in Family Medicine for medical practitioners
- ii. To encourage professional development of practising medical practitioners
- iii. To improve standards and quality in Family Medicine practice by adopting holistic patient-centered care via an integrated care approach

### 2 SYLLABUS.

The CCEFM consists of THREE segments, including Modules III, IV (FM attachment + Update) and parts of Module V in the Diploma in Family Medicine (DFM). Doctors who have graduated from the CCEFM are expected to have acquired the following essential concepts and course contents:

- i. The role of Family Doctors particular in providing cost-effective primary care to the community
- ii. The essential knowledge and skills on common problems encountered in Family Medicine
- iii. Enhancement in the consultation and problem solving skills
- iv. Acquiring the knowledge and skills in common practice procedures related to family practice

### 3. AWARDS/CREDITS:

- i. After completion of all the components and course requirements (max. within TWO years), a certificate will be awarded to the successful candidates
- ii. The completed modules and credits can be accredited towards the quotable HKCFP DFM course, if the candidates would like to enroll into DFM course subsequently
- iii. 25 CME and 5 CPD credit points will also be awarded by HKCFP.

### 4. COURSE CONTENT:

### Segment I - Essentials of Family Medicine (Structured Seminars)

### Objectives

- Strengthen knowledge in Family Medicine
- Understand the potential growth of Family Medicine
- Enable evidence-based Family Medicine practice

### **Contents:**

Anticipatory Care, Elderly Care and related issues, Chronic Disease Management, Common Musculoskeletal Problems, Evidence Based Medicine & Critical Appraisal, Mental Health, Practice Management; and Clinical Audit, Research & Teaching in Family Medicine.

### **Segment II - Problem Solving and Clinical Updates**

### **Objectives:**

- Acquire in-depth knowledge by clinical scenario/simulated cases in our daily Family Medicine practice
- Transfer the practical skills and hand-on experience by interactive learning methods led by Family Medicine Fellows

### **Contents**:

A site visit plus scenario based training including Diagnostic Challenges on Common Symptoms, Problem-based Learning on Chronic Disease, Motivational Interviewing, Child Health, Women's Health, Men's Health and Aging and End-of-Life.

# Segment III - Practical Family Medicine (Practical Workshops)

### Objectives:

- Enhance practical and communication skills in Family Medicine by practical workshops in selected areas
- Transfer the practical skills and hand-on experience by interactive learning methods

### **Contents:**

One compulsory and one elective Practical Workshops in selected areas including Consultation Skills, Counselling Skills, Women's Health, Orthopaedic Injection and Musculo-Skeletal Medicine

# 5. ADMISSION REQUIREMENTS:

Registered Medical Practitioner with Bachelor's degree in Medicine.

### 6. TEACHING STAFF:

A panel of experienced academic medical professionals in Family Medicine, hospital specialists and experienced Fellows or Trainers of HKCFP will be invited to teach in the programme.

# Diploma in Family Medicine (HKCFP) 2025-2026

The Board is pleased to announce that the Diploma Course in Family Medicine (DFM) organized by The Hong Kong College of Family Physicians will commence in August 2025.

The course consists of FIVE modules. Modules I & II will be delivered by Local Distance Learning. Modules III, IV & V consist of lectures, seminars, tutorials, workshops and FM clinical skills enhancements. The whole course requires ONE year of part-time study.

Details of the course are as follows:

### 1. Objectives:

- i) To provide knowledgeable, pragmatic and structured teaching in Family Medicine for medical practitioners
- ii) To encourage professional development of practising medical practitioners and to provide an intermediate step to fellowship qualifications in Family Medicine.
- iii) To improve standards and quality in the practice of Family Medicine

### 2. \*Syllabus:

The course consists of FIVE compulsory modules. Doctors who have graduated from the course are expected to have acquired:

- i) Current concepts about nature of Family Medicine
- ii) Knowledge and skills in consultation, counselling and problem solving
- iii) Knowledge and skills in common practice procedures and emergency care required for good quality family practice
- iv) Understandings towards the role of Family Doctors as gatekeepers of the health-care system and in providing cost-effective primary care to the community

## Module I - Principles of Family Medicine (Distance Learning)

Aims:	Learn concepts of Family Medicine     Understand the role of a Family Doctor and scope of Family Medicine
Contents:	Definition of Family Physicians, Family Physicians' Functions, Core Values of Family Medicine, Consultation, Future of Family Medicine

### Module II - Common Problems in Family Medicine (Distance Learning)

Aims:	Enhance consultation, communication and problem solving skills     Understand the diagnostic formulation process in Family Medicine
Contents:	Four clinical scenarios. Each clinical scenario is further divided into several questions covering different areas in general practice

### \*Module III - Essentials of Family Medicine (Structured Seminars and Tutorials)

Aims:	Strengthen knowledge in Family Medicine     Understand the potential growth of Family Medicine     Develop research and teaching skills in Family Medicine
Contents:	Practice Management, Care of Elderly, Chronic Disease Management, Anticipatory Care, Clinical Audit & Research, Mental Health, Musculo-skeletal Problems, Evidence Based Medicine & Critical Appraisal

### \*Module IV - Clinical Updates (Updates and FM Clinical Skills Enhancements)

Aims:	Acquire in-depth knowledge and practical skills in selected specialties
Contents:	THREE update seminars

## \*Module V - Practical Family Medicine (Practical Workshops)

Aims:	Enhance practical and communication skills in Family Medicine by Practical Workshops in selected areas including CPR, Consultation Skills, Counselling Skills, Women's Health, Orthopaedic Injection and Musculo-Skeletal Medicine
Contents:	Four compulsory and two elective Practical Workshops in selected areas including Advanced Primary Care Life Support (APCLS), Consultation Skills, Counselling Skills, Women's Health, Orthopaedic Injection and Musculo-Skeletal Medicine

<sup>\*</sup>Modules III - V would be scheduled on Saturday and Sunday afternoons.

### 3. Articulations

The Course allows (up to a fixed maximum percentage of the Course units) articulations or cross recognition of previous Family Medicine training programmes that provide learning units equivalent to that of the above syllabus. Participants who wish to apply for such articulations have to submit evidence of relevant training together with their applications. The granting of articulations is however, completely at the discretion and decision of the Board of DFM.

### 4. \*Schedule:

The whole course requires ONE year of part-time study.

May /June 2026	Final Examination

- 3. The research must be original work of the investigator(s).
- 4. The research should have been conducted in Hong Kong.

- 6. The paper should be presented under the standard headings of Abstract, Introduction, Methodology, Results, Discussion and Conclusion. References should be listed in full at the end in Vancouver format.

## **Assessment Criteria:**

- 3. How well is the research designed?
- 4. How well are the results analyzed and presented?

# CME/CPD Compliance 2023-25 Cycle

Dear Colleagues,

Please be reminded that this is the last cycle year for cycle 2023-25. You can check your HKCFP CME report by visiting the College website at https://www.hkcfp.org.hk/cme\_mchkcme\_report.aspx (Membership login is required)

The committee wishes to highlight that colleagues **must engage in ALL categories of activities** in order to fulfill the **QA Certificate 2023-2025** criteria, briefly summarized as follows:

- (1) A minimum of 90 points in total, including at least 30 CPD points
- (2) A maximum of 45 credit points will be counted for each category of educational activities
- (3) Participants must engage in **ALL** categories of activities
- (4) Maximum points set for Subcategories (3.01, 3.02, 3.03a-c, 3.04, 3.09, 3.10)

For Point (2) and (3) above, the 'categories' are referring to

- i) Category 3, related to CPD activities,
- ii) Category 4, related to activities organized by our College alone, and
- iii) Category 5, related to pre-accredited activities organized by other professional institutions themselves or in collaboration with our College. Examples of this category include accredited educational events by the Hong Kong Medical Association, The Universities, the Hospital Authority, and the Primary Care Office / Department of Health.

To obtain CME Certificate 2025, Members should obtain at least 30 Credit Points in either CME or CPD or both.

In particular, **HKAM Fellows** are required to obtain the minimum of 90 points, including **at least 15 CPD points** in a 3-year cycle (2023-2025).

Please be reminded that **ONLY CPD points** would be accredited, for teaching medical students in Universities.

# Who should get vaccinated against RSV? The latest recommendations on the use of RSV vaccines in Hong Kong

# What is RSV?

Respiratory syncytial virus (RSV) is a common pathogen causing, as its name suggests, acute respiratory tract infections. Transmitted via droplets or secretions, it can affect people of any age, and mostly causes mild flu-like symptoms such as fever, cough, runny nose, headache or malaise. The treatment of RSV infections is generally supportive.

# Why is it important to be aware of RSV?

Whilst RSV mostly causes mild infections, young children and older adults are at risk of developing severe illnesses such as bronchiolitis and pneumonia. According to local data from the Centre for Health Protection (CHP), the annual cumulative RSV-associated hospitalisation rates for children under the age of five years ranged from about 900 to 1300 per 100 000 population. Among elderly persons aged 75 years and above, the annual cumulative RSV-associated hospitalisation rates ranged from about 60 to 160 per 100 000 population, and the mortality rate is about 5 per 100 000 population. As we can see, the RSV disease burden in Hong Kong should not be neglected.

# Vaccines against RSV

Fortunately, there have been major successes in the development of RSV vaccines in recent years. As of today, two RSV vaccines, Arexvy and Abrsyvo, have been registered for use in Hong Kong.

In May 2023, Arexvy became the first RSV vaccine to be approved by the U.S. Food and Drug Administration (FDA). Initially only for use in adults aged 60 years and older, the FDA later expanded its approval for the prevention of lower respiratory tract diseases (LRTD) caused by RSV in adults aged 50 to 59 years of age who are at increased risk. Arexvy was registered in Hong Kong in late 2023.

Abrysvo, another RSV vaccine available, has been approved for use in adults aged 18 and above. More importantly, it is currently the only RSV vaccine approved by the FDA for use in pregnant women at 32 to 36 weeks of gestation to prevent severe LRTD caused by RSV in infants under six months of age. Abrysvo was made available in Hong Kong in July 2024.

Clinical trial results showed that these vaccines are generally well tolerated with acceptable safety profiles. However, recent post-marketing observations have suggested an increased risk of Guillain-Barré syndrome with Abrysvo and Arexvy, leading to the FDA's requirement to update the safety labelling of these vaccines in January 2025.

Although not yet available in Hong Kong, there is a third vaccine called mResvia that has been registered for use in the United States and European Union, and there are also over 20 more vaccines still in clinical development.

# The latest recommendations in Hong Kong

The Scientific Committee on Vaccine Preventable Diseases (SCVPD) has just recently in mid-January 2025 reached a consensus on the use of RSV vaccines in Hong Kong,

after reviewing scientific evidence, local epidemiology and recommendations of the World Health Organisation (WHO) and other international health authorities.

The SCVPD does not currently recommend universal RSV vaccination for all elderly persons, although elderly persons, especially those aged 75 years and above or living in residential care homes, may receive the vaccination as an individual decision for personal protection after discussion with their doctor.

Similarly, the SCVPD does not currently recommend universal RSV vaccination for all pregnant women to protect their newborn against severe RSV disease, although pregnant women may receive the vaccine as an individual decision after discussion with their family doctor or doctor providing antenatal care.

Given that the development of RSV vaccines is relatively new, with many vaccines still in clinical development and with post-marketing analysis still actively ongoing, it is likely that the WHO and other overseas authorities will soon update their recommendations on the use of RSV vaccines, and so too will the SCVPD review its recommendations for Hong Kong.

# What we as family doctors can do

Although universal vaccination is not yet recommended in Hong Kong, the RSV vaccines have shown to be effective in preventing RSV-associated LRTD among elder persons and infants born to vaccinated mothers. As family doctors, we should be more aware of RSV diseases and the available vaccines so that we are able to discuss its use with our patients. We should keep an eye out for the latest RSV vaccine developments and for further updates on the recommendations by the SCVPD. Last but certainly not least, vaccine or no vaccine, we should promote general measures such as encouraging good personal and environmental hygiene to prevent infectious diseases related to all pathogens.

# AI in FM

The integration of Artificial Intelligence (AI) into family medicine promises evolution in healthcare delivery. By boosting diagnostic accuracy, enhancing patient monitoring, streamlining administrative tasks, and providing personalized care, AI has the potential to significantly improve patient outcomes and system efficiency.

# Al Development: An Overview

Al refers to the simulation of human intelligence in machines programmed to think and learn like humans. From basic pattern recognition to complex decision-making processes, Al encompasses various techniques including machine learning, natural language processing, and deep learning. Over the last decade, Al has undergone significant advancements thanks to progress in computational power, data availability, and algorithmic sophistication.

Machine learning, a subset of AI, is particularly noteworthy. It enables computers to learn from and make decisions based on data. This contrasts with traditional programming where specific instructions must be manually coded. Another critical development is the advent of deep learning, which uses neural networks with many layers (hence "deep") to analyze complex patterns in large datasets, often exceeding human performance in tasks such as image and speech recognition.

# AI in Medicine: Revolutionary Potential

In the medical field, Al's potential is vast. It promises to enhance diagnostic precision, improve patient outcomes, and streamline operations. Al algorithms can analyze medical images, predict disease outbreaks, and even suggest treatment plans. Besides enhancing clinical decision-making, Al can assist in administrative tasks, reducing the burden on healthcare providers and allowing them to focus on patient care.

# **Building Confidence in Al Adoption**

As AI continues to advance, it is vital for healthcare professionals in family medicine to confidently embrace these technologies and continuously build their understanding of AI. The Hospital Authority's AI Lab, through its collaboration with local and international organizations, is leading the exploration of innovative

projects within the healthcare system. Family medicine practitioners can leverage these advancements to optimize their services and adopt data-driven care models.

# AI at the Hospital Authority

In 2020, the Hospital Authority (HA) established an artificial intelligence strategy framework and has been actively setting up processes and infrastructure to support the development and application of AI, one of which is the Hospital Authority AI Lab.

This physical laboratory has become a pioneer in promoting AI innovation:

- Facilitating the exchange of ideas for AI projects and launching proof-of-concept projects through both internal and external collaborations.
- Establishing data and integration infrastructure to validate Al solutions.
- Promoting the large-scale adoption of AI technology in HA services.

The AI Lab is equipped with advanced AI computing infrastructure, transforming AI research and technological concepts into service benefits. Users can carry out data management, data labeling, code version control, resource allocation, and visualization of AI results on the AI Lab platform. This platform improves cross-professional collaboration and the efficiency of AI development projects.


Over the past few years, the HA has developed and validated numerous AI projects to meet three goals:


- Alleviating workload
- Enhancing clinical quality
- Improving patient experience

Let's take a look at some examples.

# Chest X-ray Lesion/Nodule Localization

Al chest X-ray projects have been implemented in general outpatient clinics and some emergency departments. This initiative has significantly reduced the time required to complete reports, reduced manual secondary screening by 80%, and provided decision support for abnormal images. For instance, the Clinical Management System (CMS) marks cases with suspicious lesions or nodules.







# Al-Assisted Brain CT Scan Examination

Based on deep learning computer models, coupled with brain CT scans and annotations by doctors, this system is used to detect and classify various types of intracranial hemorrhage (ICH) and monitor the severity of midline brain shifts. Additionally, these computer models can estimate the volume of the affected brain areas, assisting doctors in evaluating patient conditions and in surgical planning.

# Nasogastric Tube (NGT) placement confirmation

By analyzing X-ray images, AI models can detect whether a nasogastric tube is placed in the correct target location and can display attention maps of the X-ray images to improve prediction accuracy, allowing doctors to quickly reposition the tube as needed.





# **Detecting Hip Fractures**

This AI model can automatically detect "hips" or "pelvis" on X-rays, locate the femoral neck, and filter out cases with prosthetics, thereby improving the accuracy of diagnosing hip fractures. If an abnormality is detected on an X-ray, the AI model supports clinical decision-making by alerting doctors in the CMS to review the patient's clinical condition for immediate diagnosis and appropriate treatment arrangements.

Improving Patient Monitoring and Personalized Care

Al-powered remote monitoring tools enable continuous tracking of patient health metrics, especially beneficial for chronic disease management. Tailored treatment plans based on individual data ensure more effective care, shifting healthcare from reactive to proactive models. For chronic disease management, Al tools can facilitate in-home monitoring. The Al blood pressure monitoring feature in the "HA Go" app, for example, can read and record data from home blood pressure monitors, track long-term trends, and provide vital information to doctors, supporting the creation of individualized treatment plans. This empowers patients to manage their health conditions proactively from the comfort of their homes.

# Virtual Medical Assistants and Chatbots

With improved analytic and linguistic abilities, patient facing tools can further provide personalized health advice, answer common medical inquiries, and remind patients to take their medications on time. HA has implemented an AI assistant for physical therapy rehabilitation program. The tool provides personalized advice based on the following three specified movements of the patient, tracks the patient's treatment progress, and makes adjustments as needed, enabling patients to effectively manage their own physical therapy rehabilitation program.





# **Generative Al**

Generative AI can automate the creation of clinical summaries, educational materials, and decision-support content. This automation reduces administrative burden, allowing family physicians to focus more on direct patient care. Al-generated content also helps keep healthcare providers informed about the latest advancements and quidelines.

The technology has also identified potential drug targets and predicted the efficacy of candidate drugs, thus reducing development time, costs, and the number of trial participants. Notably, the first drug developed using generative AI for the treatment of idiopathic pulmonary fibrosis was developed by a Hong Kong company and entered Phase II clinical trials in 2023.

# Caveats of Using Al

The integration of Artificial Intelligence (AI) into medicine holds great promise, yet it is accompanied by several caveats that must be carefully considered to ensure its effective and ethical deployment.

# **Ethical and Bias Concerns**

The accuracy and reliability of AI tools depend heavily on the quality of the data they are trained on. AI systems can inherit biases present in the data they are trained on, which can result in inequitable treatment outcomes. Unconscious bias in healthcare data can perpetuate disparities, particularly across different socioeconomic and ethnic groups. Ensuring fairness and transparency in AI algorithms is crucial to mitigate these risks. Robust data governance practices are also essential.

# Liability and Accountability

Determining liability in the event of an error or misdiagnosis made by an AI system can be complex. Clear regulations and guidelines are necessary to define the accountability of AI developers, healthcare providers, and institutions to mitigate legal challenges.

# Regulatory and Approval Processes

The regulatory landscape for AI in healthcare is still evolving. Obtaining approval for AI-based medical devices and software can be a lengthy and complex process. Clear regulatory frameworks and guidelines are necessary to streamline the approval and adoption of AI technologies while ensuring patient safety and efficacy.

# Resistance to Change


Healthcare professionals might resist adopting Al technologies due to fear of the unknown, concerns about job security, or reluctance to change established practices. Continuous professional development and education are needed to build confidence in Al tools and encourage their adoption.

# Training and Skill Development

Healthcare providers must be adequately trained to understand and interpret Al-generated recommendations. This requires ongoing educational programs to ensure that clinicians can effectively use Al tools and integrate them into their clinical workflow without misinterpretations leading to adverse outcomes.

# Continuous Learning and Adaptation

Al systems need to be continually updated and refined based on new data and clinical practices. This requires an ongoing commitment to monitoring, evaluating, and improving these systems to ensure they remain effective and relevant in a rapidly evolving healthcare environment.



# Ethical and Psychological Impact on Patients

The use of AI in healthcare can evoke ethical and psychological concerns among patients. Some patients may feel uncomfortable or mistrustful about AI involvement in their care, fearing depersonalized treatment. Transparent communication about how AI aids in their care and the safeguards in place to protect their data is essential to address these concerns.

# **High Implementation Costs**

Deploying AI systems can be expensive, involving significant investments in technology, infrastructure, and training. For smaller clinics and healthcare providers, these costs can be prohibitive. Financial support and incentives may be required to encourage widespread adoption.

**Way forward** 

The integration of AI into family medicine in Hong Kong has the potential to enhance healthcare delivery significantly. AI can improve diagnostic accuracy, patient monitoring, and personalized care while streamlining administrative tasks. Effective collaboration among healthcare providers, AI developers, and policymakers is essential for successful and ethical adoption.

While AI has the potential to significantly enhance family medicine in Hong Kong, the caveats highlighted the necessity for careful planning, implementation, and regulation. The success of AI integration depends on addressing concerns related to data privacy, ethical issues, quality of data, interoperability, resistance to change, accountability, costs, and the risk of overreliance on technology. By considering these challenges and taking proactive measures, AI can be effectively and ethically integrated into family medicine, ultimately enhancing patient care and healthcare delivery.

By providing continuous training for healthcare professionals and engaging patients in understanding Al's role, trust and confidence can be built. This will contribute to a sustainable healthcare system that can meet future demands efficiently. Al will enable family medicine practitioners to offer precise, effective, and personalized care, ultimately improving health outcomes for the population in Hong Kong.

In summary, the future of family medicine in Hong Kong, bolstered by AI, is bright and promising. AI's integration will streamline healthcare processes, enhance diagnostic and treatment capabilities, and foster better patient engagement and education. With a focus on continuous innovation, ethical considerations, and collaborative efforts, family medicine can transform to meet the evolving needs of the community. This transformation, driven by AI, will ensure a more efficient, responsive, and patient-focused healthcare system, providing better health outcomes for all.

# The Diary of a Family Doctor【家庭醫生的日常】

# 「你可以不同意我的判斷」

方翠瑩醫生

70歲陳女士獨自來診所,不需任何輔助。

「醫生,我左邊腰痛了兩星期,特別是坐低起身起步行的時候。我最近沒有受傷,這痛以前也試過,照過 X光話退化,以前食止痛藥就不痛,但今次食了止痛藥仍痛。我看過鐵打,醫師説可能是腎的問題。」

我釐清她的徵狀,痛楚點是左側盤骨上少少,主要是活動引起痛楚,痛沒有移至下肢或腹股溝,沒有小便徵狀,沒有影響下肢神經,沒有危險[red flag] 徵狀,然後再做些下背部和下肢檢查,向她解釋:

「你痛楚的特徵和以往檢查的記錄,原因最大可能 是腰椎退化;反而因為腎臟引起的痛,例如腎石, 不大吻合...」

「如果是退化,為何食了藥也痛?我想檢查個 腎。」她打斷我講話,診症室氣氛也有點緊張。

「你可以不同意我的判斷...」

「我不是這個意思。」她的語氣緩和一點。

「我聽到你最擔心是腎的問題。我查看電腦記錄, 你大概兩個月前抽過血,腎功能正常,而大概兩個 月後的血壓高年度檢查也會抽血驗腎功能和尿蛋白,似乎不用現在又再抽血。你年頭照腰骨的X光似乎沒有腎石,但那不是最正式的檢查,可以再安排照X光,或者你可考慮到私家照超聲波。另外,我也會幫你檢查中間小便,看看有否尿道炎或腎石的端倪。單純因為上次的止痛藥未能完全止痛,不等於排除了腰椎退化的可能,止痛藥有很多選擇,也可考慮轉介物理治療。」

最後,她選擇先留小便,也同意試下不同的止痛藥,安然離開。
