## Message from the President

As highlighted in the 2025 Policy Address, social media has been recognised to have potential profound impacts on the physical, social, and psychological health of children and adolescents. (<https://www.policyaddress.gov.hk/2025/en/p234.html>) In order to mitigate the harmful effects of inappropriate or improper use of social media by the younger age groups, the Department of Health has recently formed an Advisory Group on Health Effects of Screen and Social Media Use for Children and Adolescents, headed by Dr. CHUANG Shuk Kwan, JP, Consultant Community Medicine(Family and Student Health). A wide range of professional experts and representatives from clinical specialties, health care, social, academic, administrative, information technology, and cybersecurity sectors are invited to be part of the team. And I am most honoured to be invited as a member of this group. ([https://www.studenthealth.gov.hk/english/internet/recommendations/membership\\_list.html](https://www.studenthealth.gov.hk/english/internet/recommendations/membership_list.html)) The work of this important advisory group is to focus on updating relevant guidelines to reduce the negative impact of social media on the health of children and adolescents. Please stay tuned for the final recommendations coming out from the Advisory group.

The Private Healthcare Facilities Ordinance (Cap. 633) was gazetted on 30 November 2018 to protect patient safety and rights through the introduction of a new regulatory regime for Private Healthcare Facilities. Subsequently, The Advisory Committee for Regulatory Standards for Private Healthcare Facilities

(Advisory Committee) was established in accordance with the Private Healthcare Facilities Ordinance with effect from 1 September, 2020. The Advisory Committee is chaired by Professor Raymond LIANG Hin-suen, SBS, JP, with a wide membership from the Hong Kong Academy of Medicine and its constituent Colleges, the Hospital Authority, and representatives from academia, private hospitals as well as registered medical practitioners' and registered dentists' associations. The Advisory Committee provides expert advice on matters relating to the regulation of private healthcare facilities. ([https://www.orphf.gov.hk/en/regulatory\\_regime/advisory\\_committee](https://www.orphf.gov.hk/en/regulatory_regime/advisory_committee)) A recent communication from the Office for Regulation of Private Healthcare Facilities, Department of Health, has been issued to all doctors reminding that the application period of provisional clinic licences under the Private Healthcare Facilities Ordinance (Cap. 633) will end on 13 April 2026. Hence, all eligible operators are requested to submit their applications to obtain a provisional licence before the deadline. ### Important Update: SMS Sender ID(s) Successfully Registered for #HKCFP

Dear Members,

We are pleased to inform you that the College has successfully applied for SMS Sender ID(s) with the prefix “#”.

This means that any official SMS communications from the College will now display a Sender ID starting with “#”, ensuring authenticity and helping you easily identify messages from us.

#### Official Sender IDs include:

- **#HKCFP** (general College communications)
- **#HKCFPXYZ** – where **XYZ** refers to specific events or activities. For example:
  - **#HKCFPCME** (Continuing Medical Education)
  - **#HKCFPEXAM** (Examination-related notices)
  - **#HKCFPHKPCC** (Hong Kong Primary Care Conference)

*Please note: These examples are not exhaustive; other event-specific IDs may also be used.*

Please do not click on links from unknown senders or messages that do not carry the official “#HKCFP” prefix. If in doubt, verify through the College's official website or contact our support team via [admin@hkcfp.org.hk](mailto:admin@hkcfp.org.hk).

#### How to Verify the SMS Sender:

You can confirm the legitimacy of the Sender ID by checking the official registry on the Office of the Communications Authority (OFCA) website: <https://app2.ofca.gov.hk/apps/ssrs/>

## THE 40TH CONJOINT HKCFP/RACGP FELLOWSHIP EXAMINATION FIRST ANNOUNCEMENT

The Board of Conjoint Examination is pleased to announce the following information on the 40<sup>th</sup> Conjoint Fellowship Examination with the Royal Australian College of General Practitioners to be held in 2026.

### (1) REQUIREMENTS AND ELIGIBILITY

#### CATEGORIES OF CANDIDATES:

- (a) CATEGORY I CANDIDATES MUST** be FULL OR ASSOCIATE members of BOTH HKCFP AND RACGP\* at the time of application for the Examination and at the time of the Conjoint Examination. (\*Documentary evidence is required with the application – including a valid RACGP number. All candidates are required to have renewed their RACGP membership for the year 2026/2027 on or before 31 July 2026. Failure to comply with the above may result in denial of admission to the Examination.)

**CATEGORY I CANDIDATES** are graduate doctors (FULLY OR LIMITED registered with the Hong Kong Medical Council) who are undergoing or have completed a fully approved vocational training programme as outlined in the HKCFP College Handbook for Vocational Training in Family Medicine.

After satisfactory completion of two years of approved training, Category I candidates or trainees may apply to sit the Written Examination. The two segments can be taken separately in any order, or at the same attempt. After satisfactory completion of four years of supervised training, Category I candidates may apply to sit the Clinical Examination.

**[Note:** All Category I candidates who are current vocational trainees and apply to sit the Written Examination **MUST** submit evidence of completion of at least 15 months of approved training by 31 March 2026, together with the application. Those current vocational trainees who apply for the Clinical Examination **MUST** submit evidence of completion of at least 39 months of approved training by 31 March 2026, together with the application. Candidates who have already completed vocational training **MUST** submit evidence of completion of vocational training, together with the application.

Part-time trainees **MUST** submit evidence of completion of their vocational training by the time of the Written Examination before they can apply to sit the examination.)

#### **Please Note:**

*For Category I candidates who have enrolled in the vocational training program before 31 December 2018, they will remain eligible to apply for the FRACGP before 1 March 2027, provided all requirements for Fellowship are met. All other candidates are eligible to apply for the award of International Conjoint RACGP Fellowship (ICFRACGP).*

*All successful candidates applying for the award of the RACGP Fellowship will be subject to the decision of the RACGP.*

- (b) CATEGORY II CANDIDATES** are doctors who

1. are FULLY registered with the Hong Kong Medical Council,
2. have been predominantly in general practice in Hong Kong for not less than **five** years by 30 June 2026, provided that the experiences are within the most recent 10 years,
3. must be FULL OR ASSOCIATE members of HKCFP at the time of application for the Examination and at the time of the Fellowship Examination.
4. had enrolled and passed the Diploma in Family Medicine course organized by the HKCFP, or other equivalent subject to the approval of the Board of DFM, HKCFP.
5. had fulfilled the CME/CPD requirements by obtaining both 30 CME points and 10 CPD points accredited by the HKCFP each in the 2 consecutive years (i.e. 2024-2025).

#### **Please Note:**

*Starting from 2024, Category II candidates, who are eligible to sit for our college exam, will only be awarded FHKCFP upon passing the exam, provided all HKCFP Fellowship requirements are met.*

**The eligibility of candidates of both categories is subject to the final approval of the Board of Conjoint Examination, HKCFP.**

**Application will not be processed unless all the required documents are submitted with the application form.**

### (2) FORMAT AND CONTENTS

- A.** Written Examination consists of  
 (i) Applied Knowledge Test (AKT), and (ii) Key Feature Problems (KFP)
- B.** Clinical Examination  
 Clinical Competency Examination (CCE)

### (3) PRE-REQUISITE FOR CLINICAL SEGMENTS

All candidates applying to sit for the Clinical Examination of the Conjoint Fellowship Examination **MUST** possess an APCLS (Advanced Primary Care Life Support) certificate issued by the HKCFP\*. The validity of this certificate must span the time at which the application for the Examination is made AND the time of the Clinical Examination.

**Application will not be processed unless the pre-requisite is fulfilled.**

\*Note: In regarding the APCLS certificate issued by the HKCFP, the dates of APCLS workshops & examinations for 2026 have been announced. If you do not hold a valid APCLS certificate issued by HKCFP and intend to sit for the Conjoint Examination 2026, please register AS EARLY AS POSSIBLE.

**(4) CRITERIA FOR A PASS IN THE EXAMINATION**

A candidate must pass **both** the AKT **and** KFP segments in the Written Examination before one can proceed to the Clinical Competency Examination. Candidates who failed in one segment will be required to re-attempt only the failed segment. Successful Written Examination result can be retained for three years (counting from whenever the first segment is passed). If one fails to pass both segments in three years, one has to retake both segments.

The Clinical Competency Examination can only be taken after passing both segments of the Written Examination. If one fails the Clinical Competency Examination, all the clinical stations have to be re-taken.

A candidate has to pass both the Written and the Clinical Examinations in order to pass the Conjoint HKCFP/RACGP Fellowship Examination.

**(5) APPLICATION AND EXAMINATION FEES**

Application forms are available at the College website, <http://www.hkcfp.org.hk>. Please note that the deadline for application is **9 April 2026 (Thursday)**.

For both **CATEGORY I** or **CATEGORY II CANDIDATES**:

**Application Fee** : \$3,000 (Non-refundable)

**Examination Fee** :

- Full Examination (Written + Clinical)	\$48,000
- Written Examination	
• AKT	\$12,000
• KFP	\$12,000
- Clinical Examination	\$24,000

Please make the cheque payable to **"HKCFP Education Limited"**. If a candidate applied for the Full Examination **but failed in the Written Examination, s/he will be automatically withdrawn from the Clinical Examination, and the Clinical Examination fee (\$24,000) would be refunded**.

**(6) REFUND POLICY**

If a candidate wishes to withdraw from the examination, and written notice of withdrawal is received by the College 60 days or more prior to the date of the examination, he will receive a refund of \$48,000 (for the whole examination), \$12,000 (for AKT), \$12,000 (for KFP) or \$24,000 (for the clinical examination). The application fee of \$3,000 will not be refunded.

No refund will be given if the written notice of withdrawal is received by the College within 60 days of the date of the examination.

All fees paid are not transferable to subsequent examinations.

**(8) ELECTION TO FELLOWSHIP**

Members should be aware that passing the Conjoint Fellowship Examination does NOT equate with election to Fellowship of either the Hong Kong College of Family Physicians or the Royal Australian College of General Practitioners. Those wishing to apply for Fellowship of either or both College(s) should ensure that they satisfy all the requirements of the College(s) concerned.

#### 1. Application for Additional Accreditation

The application of Additional Accreditation for the **year 2025** is now open for those activities **without prior accreditation** by QA&A Committee. For Educational Activities **under items 3.7, 3.8, 3.13, 3.14 and items 5.2 to 5.6 in QA Regulation 2023-25**, please apply in writing with relevant supporting documents and \$500 administration fee (**Non-refundable**) by cheque to QA&A Committee.

Please submit the application for Additional Accreditation with relevant supporting documents at your earliest convenience. **Relevant supporting documents are mandatory for accreditation, e.g. attendance records, photocopies of events, transcripts or published articles.** Kindly note that each application will be handled independently upon receipt of the application. Submission of additional information for the application, if any, will incur new charges.

#### 2. Application for reporting CME/CPD missing points from Pre-Accredited Activities

This application is only for the activities held **in 2025 with prior accreditation** by QA&A Committee, i.e. before the activities took place. If such credit points are missing from the CME Report, please return the **"Report on CME/CPD missing points from Pre-Accredited Activity"** together with relevant supporting documents (e.g. attendance records, photocopies of events, transcripts or published articles) to us.

### [Important] Reciprocal Recognition of Quality Assurance and Continuing Professional Development (CPD) Programs Between HKCFP and RACGP for year 2025

Dear Members,

Members of the Royal Australian College of General Practitioners, who live and work in Hong Kong and fulfill HKCFP CME & CPD requirements, **may enroll with the RACGP QI&CPD Program by reciprocal recognition between the two programs and be deemed to fulfill their minimum requirements.** Please refer to below link for the RACGP Continuing Professional Development (CPD) Program for 2023-25 triennium:

Participants of the HKCFP Quality Assurance Program who have obtained at least 30 credit points, with no less than 10 CPD points **in year 2025**, may enroll with the RACGP CPD Program through this reciprocal arrangement and be deemed to fulfill their minimum requirements of the same year.

Please noted that as required by RACGP, doctors are required to take at least one CPR course in order to meet all the RACGP CPD requirements for the 2023 – 2025 triennium. You can refer to the below link for RACGP requirements for CPR Courses:

RACGP also has the final authority of deciding whether their QI&CPD requirements are fulfilled.

17:00	Disband at the same location



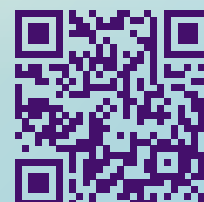

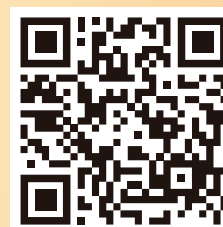

## Discussion Corner: Wearable Medical Devices

I recall watching the classic science fiction series “Star Trek” during my childhood, and the scenes are still vivid in my memory. In one of the episodes, the science officer, Captain Spock, aboard the starship Enterprise, used a handheld device, the “Medical Tricorder”, to scan himself and his teammates, effortlessly pressing a few buttons to instantly assess their health conditions. For a television series from the 1960s, this was a groundbreaking and purely imaginary concept. However, nowadays, we can personally experience these incredible technologies.

With the continuous development of technology, wearable medical & health devices have emerged as an important trend in the modern healthcare field. These smart devices combine technology and medicine, offering new possibilities for our health. Let’s take a look at some examples of wearable medical devices and how they are changing our lives and health.



As a technology enthusiast, I switched to a smartwatch a few years ago, abandoning traditional mechanical watches. In daily life, smart bands/watches not only track our steps and physical activity but also measure indicators such as heart rate, blood pressure, and sleep quality. Through smartphone applications, we can check our health data anytime and better understand our physical condition. Some smartwatches even provide basic electrocardiogram (ECG) functionality. For those who are concerned about fitness and health, this device is indispensable.

For diabetic patients, continuous glucose monitors (CGMs) are devices that can monitor sugar levels in real-time and

provide immediate feedback and suggestions through smartphone applications. Through the data collected from the CGM sensors attached to the skin, the glucose level within the interstitial fluid would be measured. This not only helps patients better control their blood sugar but also reminds them to administer insulin or adjust their diet promptly. CGMs are particularly suitable for individuals who require long-term blood sugar monitoring.

Wearable heart rate monitors can continuously monitor our heart rhythm and emit alerts when abnormalities occur. In addition to being valuable for athletes, this device can provide valuable health warnings for individuals at risk of heart disease, promptly notifying them to seek medical attention. For patients already diagnosed with arrhythmias, this device is particularly useful as it offers long-term monitoring capabilities.

In addition to the mentioned devices, there are many other types of wearable medical devices, such as sleep monitors, respiratory monitors, fall detectors, and more. These devices provide us with additional care and convenience for our health through their unique functions and purposes.

The advantages of wearable medical devices in clinical settings are undoubtedly clear. They provide health monitoring data that helps doctors understand patients’ conditions, prevent diseases, improve medical efficiency, and may offer users personalised health recommendations to enhance the quality of life, opening possibilities in daily and clinical applications in health and safety monitoring, chronic disease management, disease diagnosis and treatment, and rehabilitation. However, wearable medical devices may also have some limitations. Despite significant advancements in measurement technology, there can still be a certain degree of error. For example, in the case of heart rate monitoring, if the device is worn too loosely (e.g. which may happen for older models using chest straps), it may occasionally display inaccurate heart rate readings. Similarly, there were studies suggesting for smartwatches and portable health devices that can perform blood pressure measurements, their readings are unlikely to be as accurate as those from traditional blood pressure monitors.

In the case of continuous glucose monitors (CGMs), even though they provide a more convenient alternative to the traditional “finger-prick” method for blood glucose testing, there can still be a time lag in detecting the

interstitial fluid glucose levels compared to direct blood measurements, especially during rapid fluctuations such as intense physical activity and after meals. This time lag can vary depending on individual patient factors such as variations in subcutaneous fat thickness and may typically range from a few minutes up to around 20 minutes. Therefore, careful consideration of these results and integration of traditional laboratory testing and clinical observations are necessary when evaluating the data to make accurate judgments.

In addition, with the increase in the handling of data, there are also challenges in data management and privacy protection. How to securely store, transmit, and analyse this data has become an important issue that requires the establishment of corresponding policies and regulations to protect patient privacy.

The popularity and adoption rate of wearable medical devices are also worth considering. Despite the technical maturity of these devices, patient cooperation and willingness to use them remain a barrier in practical applications. Some patients may have reservations about new technologies and may have doubts or confusion regarding the use of wearable devices. Additionally, the pricing and affordability of these products can also influence user willingness. Furthermore, some patients may be unwilling to wear these devices for an extended period due to inconvenience or discomfort. Therefore, manufacturers may need to input greater efforts into product designs and usage promotion to make them more user-friendly, along with reconsideration of market positioning to increase public acceptance of these devices.

Another issue that needs attention is the reliability and durability of wearable medical devices. As these devices need to be worn for extended periods and endure various daily activities and environments, their reliability and durability are crucial. If these devices are prone to wear and tear or dysfunction, it can have a negative impact on clinicians' medical judgment and patient care. Therefore, when selecting wearable medical devices, we need to consider their quality and reliability and opt for products with a good reputation and proven track record.

In conclusion, wearable medical devices play an important role in modern healthcare by providing valuable data and personalised health management. However, we should also acknowledge the issues associated with these devices, such as data accuracy, privacy protection, and user willingness. Through technological innovation, policy support, and public education, we can maximise the potential of wearable medical devices and bring more benefits to public health. We should look forward to future

technological advancements that can further improve the accuracy and reliability of these devices, bringing greater benefits to our health.

## Oral GLP-1 Agonist, our future in treatment of Obesity and Diabetes?

On 16<sup>th</sup> September 2025, a phase 3 clinical trial of oral glucagon like peptide-1 (GLP-1) receptor agonist, ATTAİN-1 trial, was published in New England Journal of Medicine.

In this Phase 3, multinational, randomized, double-blind trial, safety and efficacy of orforglipron at 6 mg, 12 mg and 36 mg were compared with placebo, as an adjunct to healthy diet and physical activity for 72 weeks.

A total of 3127 patients were recruited, all patients had obesity without diabetes mellitus. At the end of the study, patient reduced ~7.5%, ~ 8.4%, ~ 11.2% of baseline body weight compared with ~ 2.1% with placebo. Baseline body weight was 103.2 kg with BMI 37.0. Apart from body weight, waist circumference from average baseline of 112.4 cm was also reduced ~ 7.1 cm, 8.2 cm, 10.1 cm respectively compare with ~ 3.1 cm with placebo. Mean non-HDL cholesterol was reduced ranging from 5.4-7.7% compare with 1.9% with placebo. Mean triglyceride was reduced ranging from 10.4%-20.2% compared with 3.8% with placebo.

Concerning safety profile, orforglipron in ATTAİN-1 was consistent with established GLP-1 receptor agonist class, most commonly reported adverse events were gastrointestinal upset. Nausea was reported in 28.9% -

33.7% vs 10.4% with placebo, constipation 21.7 – 29.8% vs 9.3% with placebo, diarrhea 21-23.1% vs 9.6% with placebo, vomiting 13-24% vs 3.5% with placebo.

For diabetic patients, the ATTAİN-2 trial evaluated orforglipron in adults with obesity or overweight who also had type 2 diabetes. This study with a smaller size of over 1600 participants with baseline glycated hemoglobin level of 8.1%, baseline body weight of 101.4 kg. Orforglipron showed a reduction in HbA1c of 1.3 – 1.8% vs 0.1 with placebo and weight reduction of 5.5%-10.5% vs 2.2% with placebo.

There are also studies of orforglipron focusing on patients with diabetes and compared with placebo, and dapagliflozin. In the ACHIEVE-2 study, orforglipron reduce A1c by 1.2 – 1.6% vs 0.8% with dapagliflozin (Baseline A1c 8.1%). In the ACHIEVE-5 study, it reduce A1c 1.6-1.9% vs 0.8% with placebo (with titrate insulin glargine, baseline A1c 8.5%).

Despite the promising results above, it is not yet available in the market. The pharmaceutical company planned to submit for regulatory review to the Food and Drug Administration of United States of America in end of 2025 for obesity and for diabetes in 2026.

**Entry and assessment criteria are listed below.**

**Entry Criteria:**

**For Best Research Paper:**

4. The research must have been completed.

**For Best Trainee Research Paper:**

1. The principal investigator has to be a trainee of the Hong Kong College of Family Physicians, or within 3 years of completion of vocational training.
2. For higher trainees who are submitting their Exit Examination research project for this award, they must have submitted their project to the Specialty Board and have passed the research segment of the Exit Examination.
3. The research must be original work of the investigator(s).
4. The research should have been conducted in Hong Kong.
5. The research must have been completed.
6. The paper should be presented under the standard headings of Abstract, Introduction, Methodology, Results, Discussion and Conclusion. References should be listed in full at the end in Vancouver format.

**Assessment Criteria:**

1. How relevant are the topic and findings to Family Medicine?
2. How original is the research?
3. How well is the research designed?
4. How well are the results analyzed and presented?
5. How appropriate are the discussion and conclusion(s) drawn?
6. How useful are the results for patient care in the discipline of Family Medicine?
7. How much effort is required to complete the research study?

Each research project submitted will be assessed according to the seven criteria listed above by a selection panel. Each criterion may attract a different weighting to be decided by the selection panel.
