Multi-disciplinary Approach to Type II Diabetes in Primary Care Setting

We are pleased to announce our final and 4th plenary session to be presented by Professor Jiten Vora, Consultant Physician at the Royal Liverpool University, Senior Clinician in Diabetes and Endocrinology.

Prof. Vora qualified from the University of Cambridge, UK, and specialized in diabetes and endocrinology as a research fellow and then lecturer at the University of Wales College of Medicine, UK. He also spent time as a Fulbright Senior Fellow at Oregon Health and Sciences University, USA. Prof. Vora has ongoing research interests in the development of/screening for/treatment of diabetic retinopathy; renal haemodynamics/function and hypertension in type 2 diabetes, where he has extensive publications in these fields.

A key clinical objective of the management of type 2 diabetes mellitus (T2DM) is to achieve glycaemic control in order to reduce the development and progression of diabetes related complications. Multi-disciplinary team, including a physician and diabetes educator, is recommended to have better result of diabetes treatment.

More than half of patients with T2DM have a HbA1c above the ADA recommended target of 7%. Failure to achieve and maintain good glycaemic control may be attributed to a number of factors. Traditional blood glucose lowering agents do not prevent the progressive loss of β -cell function in patients with T2DM.

Hypoglycaemia is a common side-effect in patients using sulphonylureas or insulin. When glycaemic targets for an individual are tightened, the risk of hypoglycaemia increases. The risk for experiencing hypoglycaemic events is further increased in those patients with declining renal function.

Declining renal function is likely to have a long-term impact on patient care, through an increased risk of hypoglycaemic and cardiovascular events. Most glucose lowering agents are partially or primarily eliminated via the kidney, and so their clearance decreases with declining renal function. This may result in increased plasma levels of the drug or its metabolites, potentially leading to an increased risk of adverse effects and/or hypoglycaemia. Conversely, drugs that are primarily excreted by routes other than the kidney may be of particular use in T2DM, in that they are unlikely to exhibit significant increases in plasma levels in patients with declining renal function, even if this has progressed as far as overt chronic kidney disease. They are, therefore, unlikely to be associated with increased levels of adverse events or inappropriate levels of blood glucose lowering in these patients.

Research Forum For Higher Trainees in Family Medicine



Prof. Doris Young

MBBS MD FRACGP Professor and Chair of General Practice, Melbourne Medical School, Associate Dean Academic, Faculty of Medicine, Dentistry and Health Sciences, The University of Melbourne

Over the last 25 years, Prof. Doris Young has been involved extensively in educating and training medical students, registrars, general practitioners and other health professionals in adolescent medicine, general practice and primary care research. She is a frequently invited keynote speaker to national and international conferences and in 2004-5, Visiting Professor of Family Medicine to University of Hong Kong and delivered the 16th Dr. Sun Yat Sen Oration for the Hong Kong College of Family Physicians. She has been the External Exit examiner for HKCFP since 2007. She is an Associate Editor of Family Practice representing the Asia-Pacific region and on the editorial board of BMC series of journals. Prof. Doris Young's current research focuses on trialling innovative models of care in the primary care setting to improve health outcomes for people with chronic diseases (Diabetes) in disadvantaged communities.

Beauty & Aesthetic Medicine Common Oral Problems in Primary Care Setting

In seminar C, we are going to discuss two commonly encountered topics raised by patients which are not covered in our conventional undergraduate or postgraduate training – Aesthetic and Oral Problems.

Beauty & Aesthetic Medicine

Dr. Kwan Kin Hung, Vincent

Specialist in Plastic Surgery

Dr. Vincent Kwan is Council member of the Society of Plastic, Reconstructive and Aesthetic Surgeons and Director of Skin Laser & Plastic Surgery Centre of St. Teresa's Hospital.

Beauty is a characteristic of a person that provides a perceptual experience of pleasure. The concept of beauty changes over time. Beauty is a subjective feeling. It is influenced by the race, culture, social economic background, personal preference and commercial advertisement.

Dr. Kwan will discuss with us the use of non-invasive or minimally invasive means to rejuvenate and restore the face to its' original beauty. Examples of aesthetic medicine are botulinum toxin and filler injection, radiofrequency and fractional laser.

Common Oral Problems in Primary Care Setting

Specialist in Oral & Maxillofacial Surgery

BDS(HK), MBChB(CUHK), FRACDS, FRCS (Edin), FHKAM(Dental Surgery), FCDSHK(Oral & Maxillofacial Surgery)

Dr. Yeung worked as a Medical Officer in the Prince of Wales Hospital (Head & Neck Team) and then joined the Faculty of Dentistry of the University of Hong Kong, where he taught mainly in the management of Oral Cancer in both the undergraduate and post-graduate programme; he also played an active role in the treatment of oral cancer in clinical practice. He is now in private practice.

Dr. Yeung will discuss with us the common oral problems encountered in the Primary Care setting and how to deal with them. In the seminar, various disease categories will be discussed such as red and white mucosal lesions, salivary gland diseases and the oral manifestations of systemic diseases. Updated methods of investigation and treatment will also be discussed.

Since 2008, he led the development of the Risk Factor Assessment and Management Programme (RAMP) in General Out-Patient Clinics (GOPCs) for patients with diabetes. He participated in 15 trials since 2003 in studies involving diabetic drugs, anti-hypertensive drugs, anti-viral drugs and vaccination for H5N1 Influenza virus.

Lowering HbA1c levels have been shown to significantly reduce the risk of various cardiovascular complications in diabetic patients. Despite this evidence, HbA1c is still not well controlled in most places - only 37% of patients in Hong Kong achieved the target HbA1c level of <7.0%. Thus, it is crucial to improve the treatment strategies to meet the glycaemic goal. According to the treatment algorithm developed by the American Diabetes Association (ADA) and the European Association for the Study of Diabetes (EASD), the initial step of the tier 1 treatment involves lifestyle management and the prescription of metformin. If this is insufficient, either sulfonylureas or basal insulin should be added. Currently, a number of sulfonylureas, including glibenclamide, glimepiride, glicazide and glipizide are available, and clinicians must try to select the optimal agent for their patients. The use of sulfonylureas or basal insulin have been recommended by guidelines published by different organisations. The revised consensus statement published in 2008 further emphasized that early addition of basal insulin should be implemented in patients who do not meet the HbA1c target, and further intensification of basal insulin is required in patients who have difficulty reaching their HbA1c goal.

ENHANCING EARLY AND OPTIMAL **GLYCEMIC CONTROL – WHAT CAN DPP-4 INHIBITION OFFER?**

Professor Tan Choon Beng Kathryn

Dr. Kathryn Tan is currently Clinical Professor at the Department of Medicine, The University of Hong Kong. She is the immediate past president of the Hong Kong Society of Endocrinology, Metabolism and Reproduction. She also serves as a member of the Executive Board of the Asian Association for the Study of Diabetes and council member of the Asian Pacific Society of Atherosclerosis and Vascular Disease. Her main research interests relate to lipid disorders and lipoprotein metabolism, as well as the pathogenesis of atherosclerosis and diabetic vascular complications.

Type 2 diabetes mellitus is a common disorder with its long term complications being a major cause of morbidity and mortality. One of the major challenges facing health care providers in the treatment of patients with type 2 diabetes is to maintain the balance between achieving glycaemic targets while minimising adverse events. Tolerability issues and adverse events like gastrointestinal symptoms and hypoglycaemia frequently affect adherence to therapy and can have a negative impact on patient outcomes. The incretin-based therapies have lower risks for hypoglycaemia and either decrease body weight (GLP-1-receptor agonists) or are weight neutral (DPP-4 inhibitors). GLP-1-receptor agonists are injection-based whereas DPP-4 inhibitors are oral agents. As a drug class, the DPP-4 inhibitors have favourable adverse-effect profile and more convenient dosing. This new class of agents offers a potential advantage in achieving glycaemic goals for patients with type 2 diabetes without additional tolerability concerns.

How to Prepare a Reference List in a Pain Free (and Free of Charge) Way

Dr. Chan Ting Bong, Higher Trainee, NTEC

After publishing a paper on BPPV management in the HK Practitioner in Mar 2012 and submitting a clinical audit report for my Exit Exam in December 2011, I can assure you the preparation of the reference list of a scientific paper can be a very painful experience.

When I started writing my BPPV paper in around June 2010, I was using a "traditional" and in fact very stupid way in preparing my reference list: apart from the main Microsoft Word file containing the contents of my paper, I put all the references in another ".txt" file and assigned a number to each entry. When I wrote the paper, I put the temporary numbers of these references to the end of the sentences manually. After finishing the whole paper, I printed out both the Word file and the ".txt" file and tried to rearrange the numbers in the reference list manually to the correct order. However, this wasn't an easy task! A single reference could be applied to multiple sentences, and new reference may be added to the paper on proof reading. When I added a new reference to the paper, say, a new "10th" reference, I needed to shift the numbers of the other references from the 11th onward, and this process needed to be repeated when adding other new references. After multiple manual shifting of the reference numbers, significant errors could occur, and I was forced to recheck the reference list against the main text, and each error identified resulted in further manual shifting of the reference numbers...

Ridiculously, after submitting the paper to HK Practitioner in September 2010, I could still identify errors in the numbering of my reference list when I went through my paper again one year later. Fortunately I was able to correct all the errors with the new method described in this article before the paper was finally published in March 2012.

After going through this painful experience, I swore that I would find a smarter way to prepare the reference list for my clinical audit report. I heard from a professor about a type of software called "Endnote", but it cost US\$249.95 to download! Then I tried to search on the web for "Endnote alternatives", finally, I found a free-of-charge software called "Mendeley" which solved all my problems.

Now I am going to show you how to prepare a reference list accurately and easily with this software.



First of all, you need to visit <u>http://www.</u> <u>mendeley.com</u> and download the free software. After installation, the software will prompt you to create a "Mendeley" web account for storing your own library of references.

Next, you need to install a "Web importer" button to your web browser. What you need to do is to visit <u>http://www.</u> <u>mendeley.com/import/</u>, and simply drag the red "Import To Mendeley" button to your bookmarks toolbar.





The magic is about to begin. Now you can go back to your paper and start adding the references to each specific sentence. Simply place the cursor to the end of a sentence, press the "Insert Citation" button under the "Reference" tab of the Microsoft Word, then a window will pop out as below:



Type in any keywords or author's name in the window, then the preferred reference will show up. You can select more than one reference for the same sentence.



As shown in the above example, I have inserted one reference to the first sentence, and two other references to the second sentence, but the format looks very strange. No worry, you can change the style of the references to "Nature Journal" or any other style you like. Now the references are changed to numbers.


After adding all the necessary references to your paper, the most magical moment comes! Now put the cursor to the very end of the paper and press the "Insert Bibliography" button, a beautiful reference list is done!

There are still many other powerful functions in this software. For example, you can actually drag the pdf file of a downloaded reference paper to the Mendeley software, the paper will be added to your reference library with all the information including authors, title and page number correctly shown! For those papers not available in the pubmed system, such as a book chapter or an article in the HK Practitioner, you can choose to create entries manually.

If you are preparing to submit an article to HK Practitioner, please pay attention to the format of your reference list; our college requests us to prepare the reference list in "Vancouver style", but if you choose this style in the Mendeley software, a web address for direct access to the pubmed abstract page will be added to the end of each entry of the reference list. To overcome this problem, you can click the "Style" button and select "More Styles...", then a window will pop up in the Mendeley software; choose the "Get More Styles" tab, search and install "The Lancet" style. This style is actually the "Vancouver" style preferred by HK Practitioner.



After creating your reference library on the web, you can actually download all the information to any computer installed with the Mendeley software, and you can even access your library with a free of charge iPad App!

The desktop software, the iPad App, and the web account are all free, but there is no free lunch in the world. The free web account actually has a limit of 500MB and after using up this quota, you will need to purchase more web space. Don't worry! 500MB should be good enough for most of us. Currently I have 133 references in my web account, which only used up 9MB of web space!

I hope this free software makes your paper-writing a more enjoyable experience!

Diploma in Family Medicine (HKCFP) Announcement

Duxaril

Duxaril has been used for treatment of dementia and tinnitus, especially symptoms related to cerebral circulation problem. This drug has recently been drawn to attention since its manufacturer, Servier, decided to withdraw this drug from the market. As no local alternative supply of the item is available, we may need to consider other alternative treatment for patients suffering from these medical conditions in the near future. Some information about Duxaril is summarized as below:

Ingredients: Raubasine 10 mg, almitrine bismesylate 30 mg

Class: Peripheral dilators and cerebral activators

Mechanism of action: raubasine: a vasodilator; almitrine: a respiratory stimulant. Increase arterial PaO2

Indications:

- Psychobehavioral disturbances associated with cerebral aging e.g. memory loss, impaired intellectual efficiency, reduced initiative, unstable mood, emotional lability, indifference, refusal to participate in social activities.
- Some visual (chorioretinal) disorders related to the circulation.
- Cochleovestibular disorders related to the circulation (hearing loss, dizziness, buzzing sounds in the ear).

Dosage: 1/2 tab bd to 1 tab bd

Alternatives for duxaril:

Other drugs available for dementia:

- 1. Acetyl cholinesterase inhibitor: Donezipil (Aricept), Rivastigmine, Galantamine (for mild to moderate cases)
- 2. NMDA receptor anatagonist: Memantine (for moderate to severe cases)
- 3. Others: (controversial evidence)
- Vitamin B₁₂, Vitamin E
- Ginkgo Biloba extract: Dementia; cerebral and peripheral activator
- Hydergine: Signs & symptoms of mental deterioration, acute cerebrovascular disease, migraine & vascular headaches (for preventive use), peripheral vascular disorders, subjective symptoms associated with arterial hypertension
- Nicergoline: Peripheral vascular disease (PVD), mental deterioration related to cerebral vascular insufficiency
- Pentoxifylline (Trental): Vascular dementia, PVD

Other treatment options available for tinnitus / dizziness related to cerebral vascular insufficiency include:

- Identification of the underlying causes: e.g. loud noise exposure, blocking of background noises (e.g. wax, ear effusion), meniere's disease, aspirin
- Medications that increase cerebral blood flow: Instenon, Ginkgo Biloba, Nicergoline, Hydergine (controversial evidence)
- Melatonin: for those with sleep disturbance
- Tricyclic antidepressant (e.g. low dose amitriptyline)
- Non-drug treatment: stop caffeine, quit smoking, decrease salt intake, lower blood pressure, avoid fatigue and exercise, use of masking noises (e.g. radio)

Update of Diagnostic Criteria of Diabetes Mellitus by WHO

After the American Diabetes Association (ADA) recommended HbA1c as part of diagnostic criteria of Diabetes Mellitus, WHO concludes in 2011 that HbA1c can be used as a test for diagnosis of diabetes. An HbA1c of 6.5% is recommended as the cutoff point for diagnosing diabetes, providing that stringent quality assurance tests are in place and the assays are standardized to criteria aligned to the international reference values. In the past, the test of HbA1c was less popular and the HbA1c assay was not well standardized, rendering it not appropriate as a diagnostic test. Currently, both the National Glycohemoglobin Standardization Programme (NGSP) and the International Federation of Clinical Chemists (IFCC) base their evaluations on reference method procedures that have further enhanced the harmonization of HbA1c assays across manufacturers. This standardized the HbA1c assay and makes it possible to use HbA1c as part of the diagnostic tests. Also, the test for HbA1c is relatively convenient as it can be performed at any time of the day and does not require any special preparation such as fasting. However, there are several points we should bear in mind when it is used for diagnosis of Diabetes:

- 1. At least one additional HbA1c or plasma glucose test result with a value in the diabetic range is required in asymptomatic person to make a diagnosis. This can be from a fasting, or a random (casual) sample, or from the oral glucose tolerance test (OGTT).
- 2. If both glucose and HbA1c are measured and both are "diagnostic" then the diagnosis is made. If only one is abnormal then a further abnormal test result, using the same method, is required to confirm the diagnosis.
- 3. A value of HbA1c less than 6.5% does not exclude diabetes.
- 4. There are many factors that can affect the level of HbA1c as mentioned in the WHO report.

In summary, the diagnostic criteria of Diabetes mellitus:

Fasting glucsoe \geq 7.0 mmol/l

Or

2-h glucose ≥ 11.1 mmol/l

Or

HbA1c ≥ 6.5%

In an asymptomatic person at least one additional HbA1c or plasma glucose test result with a value in the diabetic range is required.
